More over, Laptop shall be the asset of the respective office and should be taken on the Asset /Dad stock Register of the respective office/departments.
- 4. Laptop shall be procured within the price ceiling of Rs.50000/- and from the budget provision of the respective department/office and it will be purchased as per the rate list circulated by Gujarat Informatics Ltd. only.
- 5. The insurance of the laptop will be obtained by the respective department/office.
