SCOPE OF WORK

Objective:

DST, Govt. of Gujarat desire to provide

- (1) MPLS-VPN based connectivity (including last mile connectivity with equipment, installation and commissioning) at anywhere in State of Gujarat for connecting these locations to GSWAN.
- (2) MPLS-VPN over broadband at anywhere in State of Gujarat for connecting these locations to GSWAN.

Bidder has to provide the MPLS-VPN connectivity at the various locations. The dedicated bandwidth required will be as per the requirement of application and user.

Activities:

- 1. GoG intends to connect all these Locations with State Centre (Gandhinagar) for Data/Video/Audio using MPLS Layer 3 routing.
- 2. Bidder should provide Multi Protocol Label Switching MPLS-VPN connectivity for all the locations of Customer on a rental basis.
- 3. Bidder should do Implementation and Maintenance of the necessary network infrastructure and related hardware equipments for the above mentioned connectivity.
