SECTION I: INSTRUCTIONS TO BIDDERS (ITB)

Gujarat Informatics Limited (herein after referred to as GIL), on behalf of Department of Science & Technology, Gandhinagar (herein after referred to as the Purchasers) for their requirement of Condemnation / disposal of IT assets from eWaste recyclers registered with Gujarat Pollution Control Board (GPCB) on behalf of Department of Science & Technology, Gandhinagar.

Your bid should reach at our office on or before 15:00 Hours, 18.01.2018 in sealed envelope with the heading "Bid for Condemnation / disposal of IT assets through GPCB registered eWaste recyclers On behalf of Department of Science & Technology."

Bid will be opened on 1700 Hours, 18.01.2018 at GIL office.

Eligibility Criteria for the bidder:

- 1. Bidder must be e-waste recycler registered with Gujarat Pollution Control Board (GPCB). (Registration Certificate/Passbook form GPCB and CCA form GPCB)
- 2. Bidder should not be under a declaration of ineligibility for corrupt and fraudulent practices issued by Government of Gujarat or any of the PSU in the state of Gujarat at the time of bidding. (Certificate / affidavit mentioning that the Bidder is not blacklisted by Government of Gujarat or any of the PSUs in the state of Gujarat due to engagement in any corrupt and fraudulent practices)

Documentary evidence must be furnished against each of the above criteria along with an index. All documents must be signed by the authorized signatory of the bidder. Relevant portions, in the documents submitted in pursuance of eligibility criteria, should be highlighted.

The terms and conditions are as follows:

However, GIL reserves the right to ask the bidders to submit the bid and/or any other documents/ clarifications in physical form. Each and every page of the bid must be signed and stamped by the bidder.
- 2 The bid is non-transferable.
- The bidder will have to submit copy of bid document duly signed (all pages) by the authorized signatory as a part of the bid, complying terms and conditions of bid. Failing to submit the same or non-compliance/deviation from any bid terms and conditions or eligibility criteria may result in rejection of the bid.
- The Bidder shall bear all the costs associated with the preparation and submission of its bid, and GIL in no case will be responsible or liable for these costs, regardless of conduct or outcome of bidding process.
- The Bidder is expected to examine all instructions, forms, terms and specifications in the bidding documents. Failure to furnish all information required by the bidding documents or submission of a bid not substantially responsive to the biding documents in every respect will be at the Bidder's risk and may result in rejection of its bid.
- 6 Amendment of Bidding Documents
 - 6.1 At any time prior to the deadline for submission of bids, GIL may, for any reason, whether its own initiative or in response to the clarification request by a prospective bidder, modify the bidding documents.

 - 6.3 In order to allow prospective bidders reasonable time to take into consideration the amendments while preparing their bids GIL, at its discretion, may extend the deadline for the submission of bids.
- 7 **Bid Currency:** Prices shall be quoted in Indian Rupees only.
- The Bidder will have to submit Non refundable Bid Processing Fees of Rs. 1,770/- and Earnest Money Deposit (E.M.D.) of Rs. 20,000/- (Rupees twenty thousand Only) on or before the date and hours of opening of the bids in a sealed cover at GIL office with the heading "Bid Processing fees and EMD for the E-tender for Condemnation / Disposal of ICTE assets and management of eWaste on behalf of Department of Science & Technology" Bid Processing fees must be in the form of Demand Draft in the name of "Gujarat Informatics Ltd." payable at Gandhinagar along with the covering letter. Please affix the stamp of your company on the overleaf of demand draft. - 9 In case of non-receipt of Bid Processing fees and EMD as mentioned above within prescribed time, the bid will be rejected by GIL as non-responsive.
- 10 Unsuccessful bidder's E.M.D. will be returned as promptly as possible but not later than 15 days after the expiration of the period of bid validity OR upon the successful Bidder's completion of condemnation / disposal services as described in this tender document, whichever is earlier.

- In exceptional circumstances, GIL may solicit the Bidder's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing. A Bidder may refuse the request without forfeiting its E.M.D. A Bidder granting the request will not be permitted to modify its bid.
- 12 The successful Bidder's E.M.D. will be discharged upon the Bidder on completion of condemnation / disposal services as described in this tender document.
- 13 The E.M.D. may be forfeited:
 - (a) If a Bidder withdraws its bid during the period of bid validity
 - (b) In case of a successful Bidder, if the Bidder fails:
 - (i) To sign the Contract as mentioned above or
 - (ii) To furnish performance bank guarantee as mentioned above or
 - (iii) If the bidder is found to be involved in fraudulent practices.
- Bid validity will be of 90 days after the date of price bid opening. A bid valid for a shorter period shall be rejected as non-responsive. If required, GIL / GoG may extend the bid validity for further period from the date of expiry of bid validity in consultation with the successful bidder.
- 15 Termination of Contract:
 - GIL / GOG may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Bidder, terminate the Contract in whole or part:
 - 15.1 If the Bidder, in the judgment of GIL / GOG has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.
 - "Corrupt practice" means the offering, giving, receiving or soliciting of any thing of value of influence the action of a public official in the procurement process or in contract execution.
 - "fraudulent practice: a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the purchaser, and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the purchaser of the benefits of free and open competition;"
 - 15.2 If the bidder does not start performing the contract within stipulated time period
 - 15.3 If the bidder stops performing the contract or withdraw the activity to perform the contract
 - 15.4 If the bidder breaches any terms and conditions of the contract or do not perform the contract in whole or part
 - 15.5 If the bidder does not follow the written instructions given by GIL / GOG
 - 15.6 If the bidder does not perform the contract up to the satisfactory level even after regular feedback from GIL / GOG
 - 15.7 In the event that the bidder shall cease conducting business in the normal course, or wind up, make a general assignment or the benefit of creditors, suffer or permit the appointment of a receiver for its business or assets or shall avail itself of, or become subject to, any proceeding under any act or statute of any country or state relating to insolvency or the protection of rights of creditors.

- The Bidder shall be entirely responsible for all taxes, duties, license fees, road permits, other taxes, etc., incurred during the E-Waste handling process.
- 18 Late Bids The bidder will not be able to submit the bid after final submission date and time.
- 19 Modification and Withdrawal of Bids
 - 19.1 No bids will be allowed to be modified subsequent to the final submission of bids.
 - 19.2 No bid will be allowed to withdrawn in the interval between the deadline for submission of bids and the expiry of the bid validity. Withdrawal of a bid during this interval will result in the forfeiture of bidder's E.M.D.
- 20 **Evaluation of Bids:** After the closing time of submission, GIL / GoG committee will verify the submission of Bid Processing Fees & EMD as per bid terms and conditions. The eligibility / technical criteria evaluation will be carried out of the responsive bids. GIL will seek clarifications if required on eligibility & technical section. The financial bid of the technically qualified bidders will be opened and evaluated. H1 bidder will be decided based on the highest sum total of rates of all line items inclusive of all. H1 bidder will be called for negotiations if required.
- The successful bidder shall be required to submit Non-Disclosure Agreement duly stamped as an agreement with the GIL, within 15 days of from the issuance of Work order or within such extended period as may be decided by the GIL along with the letter of acceptance, NDA, BG and other terms and conditions as may be determined by the GIL to be necessary for the due performance of the work in accordance with the Bid and acceptance thereof.
- 23 Copy of board resolution or power of attorney showing that the signatory has been duly authorized to sign the acceptance letter, contract and NDA should be submitted.
- 24 Bidders are required to quote the unit Condemnation / disposal Rates (inclusive of all applicable taxes) of all line items as per the financial bid format only. Incomplete bids will be treated as non-responsive and will be rejected.

25 Inspection, Quality Control and Audit:

- 25.1 The GIL may, at its discretion, get the services of the bidder inspected/audited by its internal/external inspectors/auditors. The bidder shall facilitate the same.
- 25.2 The bidder shall, whenever required, furnish all relevant information, records, and data to such auditors and/or inspecting officials of the GIL /GoG and or any regulatory authority/GIL"s consultant/Testing agency entrusted by the GIL to carry out this work.
- 25.3 GIL at its discretion may carryout periodic inspection/quality checks on continual basis and where necessary may reject the service which does not meet the specifications provided by the GIL.

26 **Penalty Clause:**

The successful bidder's EMD may be forfeited, if -

26.1 Successful bidder fails to collect e-waste from the GoG's locations within 30 days of issue of order for collection where the cause of delay is not attributable to successful bidder

27 Scope of Work

On behalf of Department of Science and Technology, GIL invites bids from competent and professional e-waste recyclers registered with Gujarat Pollution Control Board (GPCB), who meet the minimum evaluation criteria as specified in this bid document.

- a. GIL is looking for end-to-end solution (collection, transportation, dismantling, recycling and / or final disposal) from bidders registered with the as per GPCB guidelines currently in force and having established facilities for management of e-waste.
- b. Bidder should follow environmentally sound practices for management of e-waste as per GPCB guidelines and e-waste (Management and Handling) Rules, 2011 issued by Government of India from time to time currently and future in force.
- c. The services offered should include collection of e-waste from location mentioned in this tender document, transporting the same to collection centre, recycling facility or final disposal.
- d. Bidder should ensure that once the data is deactivated / degaussed and/or storage media is destructed, data cannot be retrieved by using any procedure. A Certificate to this effect would need to be issued to the respective GIL / GoG.
- e. If storage media is required to be transported to bidders facility for data deactivation/ degaussing and/or for destruction, it would be the responsibility of the bidder to ensure the security of data from the time it is collected from the GOG Offices and until such time it is finally disposed / destroyed.
- f. Bidder should have recording and monitoring mechanism for e-waste collection and transportation to bidders' facility and the same should be made available to the relevant GoG department.
- g. The bidders should have necessary in-house infrastructure both for on-site / off-site data deactivation / degaussing / storage media destruction. The deactivation / degaussing / storage media destruction facilities should also be made available on site, if so required by the GIL / GOG.
- h. The bidders should be able to provide the GIL with a Certificate to the effect that after deactivation/degaussing of the data and/or destruction of storage media, the data cannot be retrieved by using any procedure.
- i. All professional services necessary for e-waste management as per the guidelines issued by concerned / competent authority (State or Central government) will be part of the tender scope. Bidder should ensure the quality of methodologies for delivering the services and its adherence to quality standard as per the guidelines issued by concerned / competent authority.
- j. Bidder should follow environmentally sound practices for management of e-waste

- k. The e-Waste should be disposed off in accordance guidelines currently in force. On final disposal, the Bidder would be required to provide a Certificate to this effect to GoG within 30 days from the date of the collection of the e-Waste.

However, in any case if the requirement of Arbitration is felt then the appointment of Arbitrator will be made by GIL / GOG only and the decision of THE BIDDER shall be bound by the decision taken by such appointed Arbitrator.
- 38 Bidders' Obligation:

 - 38.2 The bidder is responsible for managing the activities of its personnel and will hold itself responsible for any misdemeanors on the part of its personnel.
 - 38.3 The bidder will treat as confidential all data and information about GIL, obtained in the process of executing its responsibilities, in strict confidence and will not reveal such information to any other party without prior written approval of GIL as explained under Non Disclosure Agreement.
- 39 **Limitation of Vendor's Liability:** Vendor's cumulative liability for its obligations under the contract shall not exceed the contract value and the vendor shall not be liable for incidental, consequential, or indirect damages including loss of profit or saving.
- The jurisdiction of any dispute will be **Gandhinagar**.
- 41 Force Majeure Shall mean and be limited to the following:
 - a) War / hostilities
 - b) Riot or Civil commotion
 - c) Earthquake, flood, tempest, lightening or other natural physical disaster.
 - d) Restrictions imposed by the Government or other statutory bodies which prevents or delays the execution of the order by the BIDDER.

Completion period may be extended to circumstances relating to Force Majeure by the GIL / GOG. Bidder shall not claim any further extension for completion of work. GIL / GOG/GoG shall not be liable to pay extra costs under any conditions.

BIDDER shall categorically specify the extent of Force Majeure conditions prevalent in their works at the time of submitting their bid and whether the same have been taken in to consideration or not in their quotations. In the event of any Force Majeure cause, the BIDDER shall not be liable for delays in performing their obligations under this order and the collection dates can be extended to the BIDDER without being subject to price reduction for delayed collection, as stated elsewhere.
