Subject: Extension of current tender HRM2803202202 for transition only

In reference to subject cited above, it is to inform that GIL Rate Contract with its empaneled agencies through Rate Contract and tender regarding Empanelment of agencies for providing "IT Technical Manpower" for GIL & Various Govt. Departments/Offices/Boards/Corporations/Company etc., (tender no. HRM2803202202) has expired on 31.03.2026.

Further, GIL has recently empaneled 12 agencies under different TIERS. Please find attached the Circular for GoG Departments including the work order issued to agencies under Tender No. HRM010202602. The unit rate mentioned in the work order is per month per resource which is inclusive all i.e service charge, CTC, labour compliances and any other benefit excluding applicable taxes. As per the provisions of the circular, the transition to the new tender framework was required to be completed by 01.04.2026. However, requests have been received from various departments seeking an extension of the existing tender period to facilitate the smooth and orderly completion of the transition process.

Considering the above and to avoid any disruption in ongoing services, it is proposed to treat this as a special case. Accordingly, the existing tender bearing no. **HRM2803202202** is hereby extended for a further limited period up to **31.05.2026**, strictly for the purpose of completing the transition to the new tender only.

It is further clarified that departments which have already completed the transition, as well as any new manpower requirements raised henceforth, shall be governed strictly by the terms, conditions, and rates of the new tender only.

All concerned are requested to ensure that the transition process is completed within the stipulated extended timeline, and no further extension shall be considered.
