

Guidelines procedure to be adopted by Government Departments to host/update their Mobile app on Common Appstore.

Circular:

Department of Science and Technology has issued circular dated 23rd February 2017 referred to at Sr. No. 1 above regarding "Guidelines procedure to be adopted by Government Departments to host/update their Mobile app on Common Appstore." One of the provision of the said guidelines is as under:

GIL's Mobile App Administration Team is responsible for hosting/updating the mobile app on behalf of various departments and will facilitate them for hosting their apps on a Common Appstore.

2. GIL vide note dated 14th August 2018 referred to at Sr. No. 2 above has mentioned that there is an effort to provide technical assistance and facilitation for hosting Mobile Apps on Appstore. GIL has proposed to approve Rs.5,000/- per mobile app as GIL's service charges towards technical assistance and facilitation services. Further GIL vide email dated 19th October 2018 has submitted process details to upload Mobile Application on Google Play Store (Android), App Store (Apple) and on Microsoft Windows Platform.

3. In view of the above and after careful consideration, it is decided to approve Rs.5,000/- per mobile app as GIL's service charges towards technical assistance and facilitation services for hosting Mobile Apps on Appstore.
