Preamble:

The State Government has announced the Policy Guidelines for Condemnation / Disposal of ICTE assets & Management of eWaste for Gujarat State, DST GR No. COB-2004-394-DST dated 24.12.2014 which states following:

Para 3-Pre-requirements to be followed by Every Department before CD Activity:

4. Any procedure (Condemnation / Disposal) that requires third party agency participation (other than the Government) should be carried out through rate contract of GIL empanelment.

Para 5-Policy for Condemnation:

C. Recommended Guidelines for Condemnation:

- d. GIL will execute rate contract with this / these recycler / recyclers for all the various items as per their technical specification, condition and aging period.
- e. All State Government Departments shall prepare a list of goods to be disposed off under this policy every year by 1st January, 1st July and send it GIL to identify a suitable authorized & empanelled eWaste recycler / recyclers to collect and dispose the eWaste in environment friendly manner.

Para 6-Scrapping/ Disposing as eWaste:

D. GIL shall act as a nodal agency for empanelment of agencies and price of different

goods to be disposed-off by different Government Department / Government Agencies

under this policy.

E. The respective department shall follow such GIL Rate contract as a practice for the

eWaste disposal.

The matter of GIL for finalizing Rate Contract of different ICTE assets to be condemned / disposed

as well as carrying out empanelment was under consideration. After careful consideration, State

Government is pleased to issue the following amendment / clarification to the Policy Guidelines

for Condemnation / Disposal of ICTE assets & Management of eWaste for Gujarat State issued vide

DST GR No. COB-2004-394-DST dated 24.12.2014

Resolution:

State Government is pleased to make following amendment in the DST GR No. COB-2004-394-DST

dated 24.12.2014:

"Government of Gujarat (GoG) Department" / Offices shall use the list of GPCB registered

eWaste recyclers for condemnation / disposal of ICTE assets based on their requirement.

GoG departments / offices shall invite GPCB registered eWaste recyclers for physical

verification of the ICTE assets to be disposed & then invite financial quotes from GPCB

registered eWaste recyclers for the ICTE assets to be condemned. GoG departments /

offices shall award the work pertaining to condemnation / disposal of ICTE assets to the

empanelled agency who has quoted the highest rate."

The provisions of above paras mentioned in preamble are amendment accordingly.
