Circular:

Department of Science and Technology (DST) on behalf of Government of Gujarat (GoG) has issued a circular dated 24.03.2004, 25.03.2004 and 30.01.2009 to provide The facility of Laptops to the government officers who are Super-time scale officers in the pay scale of Rs. 18,400-500-22400 and above or are Heads of Department (in the Pay Scale of Rs. 12,000-375-16500 and above) declared under the Rule 9(34) of Gujarat Civil Services Rules-2002 within the price ceiling of Rs.50,000/- and from the from the budget provision of the respective department/office and it will be purchased as per the rate list circulated by Gujarat Informatics Ltd. only. The insurance of the laptop will be obtained by the respective government department.

- 2. Now days, the average price discovery in laptop rate contract by GIL is above Rs. 50,000. Due to limitation of price ceiling in earlier circular, GoG departments are unable to procure laptop above Rs. 50,000. In various departmental IT Committee and SPC (IT), the request raised to amend the price ceiling in the earlier issued circular dated 30.01.2009 of this department.
- 3. After careful consideration, Government is pleased to amend that the Government officers who are super time scale officers as mentioned above may purchase laptop within the price ceiling of Rs. 60,000 /-. Other terms conditions will remain same as per circular dated 30.01.2004 of this department.
