Circular:

Department of Science and Technology (DST), on behalf of Government of Gujarat (GoG) has setup the Gujarat State Data Centre (GSDC) in Gandhinagar, for providing Shared Infrastructure, Application/Website/Database-hosting, Server, internet, Network, Firewall, helpdesk, physical infrastructure and other data centre related services to all Departments of Government of Gujarat. The GSDC is now functioning as a central repository for all IT and e-governance services of GoG. In order to enhance the services of GSDC and to provide seamless e-governance services, DST has undertaken an upgradation of both GSDC & GSWAN, and also consolidated the Operations & Management (O&M) of both GSDC and GSWAN, under the purview of a single O&M Vendor. As both GSDC & GSWAN are progressing towards a centralized IT operations and management, it is essential for the operations team to have access to all the devices in case of any emergency situations for troubleshooting or performing graceful shutdown during power failure...etc.

2. In this regard, to assist the smooth operations & management of both GSDC and GSWAN, the Government Departments are requested to hand-over one set of administrator credentials of their respective hardware devices (hosted at GSDC) to the Project Manager - Composite Team, Gujarat State Data Centre along with the credentials, the Government Departments are also requested to fill-up a device information template (the template will be provided by GSDC) to provide necessary details of their hardware devices and submit it (in person) along with the login credentials to the GSDC Team at the following address:
