


Amendment in Policy Guidelines for Local Area Network (LAN) Hardware and System Integrators Procurement.

- 3. The matter of inclusion of this condition under the clause A. Bidder's Eligibility Criteria of the GR No: LAN-2004-927-DST dated 30-7-2004 was under consideration of the Government.
