**Circular:**

M/s GTPL Broadband Pvt. Ltd. has been selected as a service provider for providing the Wi-Fi services on Service/Rental Model including (Design, Built, and Operations & Management) for State-wide Public Wi-Fi Hotspot's under Gujarat State Urban Area Network (GSUAN). With prior approval of IT Committee of DST and SPC (IT) committee; GIL has placed the work order to M/s GTPL Broadband Pvt. Ltd. as a service provider for execution of the said project.

2) In the said project, M/s GTPL Broadband Pvt. Ltd. has setup the Wi-Fi infrastructure at locations such as City Bus Stand/Depot, Nagarpalika, Mamlatdar Office, TDO office, District/Taluka Court, District/Taluka Library, Civil Hospital etc. through deployment of 2 to 8 nos. of wireless Access Points with 30 mbps to 100 mbps bandwidth for providing internet access.

3) The Wi-Fi hotspots are aimed at providing the Internet access to citizens at public places. The Project will serve more than 3 lakh concurrent users.

4) The main objective of the project is to establish and provide Public Internet Access infrastructure to its citizens, Tourists, students and empower them as netizens by providing reliable and convenient Internet Wi-Fi connectivity at cities. In addition to the above, this project will help to enable and spread the following:

- Internet access facility
- Education and Digital Literacy
- Quick Access to Information
- Awareness and the information exchange digitally
- Convergence and utilization of the Government Services to its Citizens

5) The free Wi-Fi service at Public Wi-Fi Hotspot's under Gujarat State Urban Area Network (GSUAN) has been implemented and **it is in 'Go live' stage since 22.01.2018.**


