Gujarat Informatics Limited (herein after referred to as GIL), on behalf of Department of Science & Technology, Gandhinagar (herein after referred to as the purchaser's) for their requirement of Routers intend to invite your bid for supply, installation & commissioning of Routers on behalf of Department of Science & Technology, Gandhinagar (Tender no. HWT060317419). The installation of the routers needs to be carried out at GSWAN Nodes, PoP, office Locations spread across the State as specified by DST/GIL.

- Bidder shall upload reference documents (contact details, project completion certificate / ongoing certificate, customer satisfaction certificate etc.) of the projects satisfying the eligibility criteria of the bid. All the details should be uploaded in Eligibility Criteria Section of the bid as per given format. If the bidder does not meet the eligibility criteria, his bid will be rejected and no further evaluation will be done.
- Bidders who wish to participate in this bid will have to register on <https://gil.nprocure.com> Further bidders who wish to participate in online bids will have to procure Digital Certificate as per Information Technology Act 2000 using which they can sign their electronic bids. Bidders can procure the same from (n) code solutions – a division of GNFC Ltd., or any other agency licensed by Controller of Certifying Authority, Govt. of India. Bidders who already have a valid Digital Certificate need not procure a new Digital Certificate.

Brief Scope of Work:

1. The bidder is required to supply, install, configure and commission the procured router at the defined locations within the existing GSWAN network. After successful completion of FAT bidder is required to handover the installed devices to the current GSWAN operator for O&M of the same. However, bidder is responsible for providing warranty and onsite support for the period of five years from the date of successful completion FAT.
2. The bidder will have to hand over all the details of software, licenses to GSWAN O&M team after completion of installation.

General Terms and conditions:

- 1) The bid is non-transferable.
- 2) The last date of submission of bid on the website <https://gil.nprocure.com> is 1500 Hrs. 21/03/2017. No physical bids will be accepted under normal circumstances. However, GIL reserves the right to ask the bidders to submit the bid and/or any other documents in physical form.
- 3) The Bidder shall bear all the costs associated with the preparation and submission of its bid, and GIL in no case will be responsible or liable for these costs, regardless of conduct or outcome of bidding process.
- 4) If in any case the quoted Item is not available in the market, the bidder will have to supply Higher Version/replacement of that Item in the quoted cost in the same time duration with prior approval of GIL.
- 5) The Bidder has to upload the compliance letter on its letter head duly signed by the authorized signature & other supporting documents as asked for in the bid in the scanned format. Failing to submit the same or non-compliance/deviation from any bid terms and conditions, eligibility criteria or technical specifications may result in rejection of the bid.
- 6) The Bidder has to examine all instructions, forms, terms, conditions and specifications in the bidding documents. Failure to furnish all information required by the bidding documents or submission of a bid not substantially responsive to the bidding documents in every respect will be at the Bidder's risk and may result in rejection of its bid.
- 7) Amendment of Bidding Documents (Corrigendum)
 - 7.1 At any time prior to the deadline for submission of bids, GIL for any reason, whether at its own initiative or in response to the clarifications requested by prospective bidders may modify the bidding documents by amendment & put on our websites.
 - 7.2 The corrigendum will be published on website <https://gil.nprocure.com> & <https://gil.gujarat.gov.in>
 - 7.3 All prospective bidders are requested to browse our website & any amendments/corrigendum/ modification will be notified on our website and such modification will be binding on them.
 - 7.4 In order to allow prospective bidders reasonable time to take into consideration the amendments while preparing their bids GIL, at its discretion, may extend the deadline for the submission of bids.
- 8) Bid Currency - Prices shall be quoted in Indian Rupees only.
- 9) The Bidder will have to remit Bid Processing Fees (Nonrefundable) of Rs. 15,000/- & Earnest Money Deposit (E.M.D.) of Rs. 5,00,000/- on or before the date & hours of opening of the bids in a sealed cover at GIL office with the heading "Bid Processing fees & EMD for the e-Tender No. HWT060317419 for supply, installation & commissioning of Routers on behalf of Department of Science & Technology, Gandhinagar."
 - Bid processing fees must be in the form of Demand Draft in the name of "Gujarat Informatics Ltd." payable at Gandhinagar along with the covering letter. Please affix the stamp of your company on the overleaf of demand draft.
 - EMD shall be submitted in the form of Demand Draft OR in the form of an unconditional Bank Guarantee (which should be valid for 9 months from the last date of bid submission)

All Nationalized Bank including the public sector bank or Private Sector Banks or banks (operating in India having branch at Ahmedabad/Gandhinagar) as per the G.R. no. EMD/10/2015/508/DMO dated 27.04.2016 issued by Finance Department or further instruction issued by Finance department time to time in the name of "Gujarat Informatics Ltd." payable at Gandhinagar (as per prescribed format given at as per prescribed format given at Annexure A) and must be submitted along with the covering letter.

- **Note:** Failing to submit physical covers of EMD and bid processing fees at GIL on or before **21.03.2017 up to 1500 Hrs** hours may lead to the rejection of the bid.

- 10) In case of non-receipt of Bid processing fees & EMD as mentioned above, the bid will be summarily rejected by GIL as non-responsive.
- 11) Unsuccessful/Disqualified bidder's E.M.D. will be returned as promptly as possible but not later than 15 days after the expiration of the period of bid validity OR upon the successful Bidder signing the Contract, whichever is earlier.
- 12) In exceptional circumstances, GIL may solicit Bidder's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing. The Bid security shall also be suitably extended. A Bidder's request to modify the Bid will not be permitted.
- 13) The Successful bidder has to submit Performance Bank Guarantee @ 10% of total order value within 15 days from the date of issue of Purchase order (for warranty period + extra 3 months) from All Nationalized Bank including the public sector bank or Private Sector Banks or banks (operating in India having branch at Ahmedabad/ Gandhinagar) as per the G.R. no. EMD/10/2015/508/DMO dated 27.04.2016 issued by Finance Department or further instruction issued by Finance department time to time. (The draft of Performance Bank Guarantee is attached herewith).
- 14) Successful Bidder will have to sign the contract with the purchaser(s) within 7 days from the date of receiving the confirmed purchase order. (The draft is attached herewith)
- 15) The successful Bidder's E.M.D. will be returned upon the successful Bidder signing the Contract, and furnishing the Performance Bank Guarantee @ 10% of the total order value and offer of inspection of the ordered material.
- 16) The E.M.D. may be forfeited:
 - a) If a Bidder withdraws its bid during the period of bid validity
 - b) In case of a successful Bidder, if the Bidder fails:
 - i. To sign the Contract as mentioned above or
 - ii. To furnish performance bank guarantee as mentioned above or
 - iii. If the bidder is found to be involved in fraudulent practices.
- 17) Termination for Default
 - 17.1 The Purchaser may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Bidder (after providing notice/cure period of 30 days), terminate the Contract in whole or part:
 - a) if the bidder fails to deliver any or all of the Goods within 4 weeks from the date of issuance of the purchase order, or within any extension thereof granted by the Purchaser or
 - b) If the Bidder fails to perform any obligation(s) under the Contract/Purchase order.
 - c) If the Bidder, in the judgment of the Purchaser has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.

"Corrupt practice" means the offering, giving, receiving or soliciting of any thing of value of influence the action of a public official in the procurement process or in contract execution.

"fraudulent practice: a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the purchaser, and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the purchaser of the benefits of free and open competition;"
 - 17.2 In the event the Purchaser terminates the Contract in whole or in part, pursuant to Clause 17.1 above, the Purchaser may procure, upon such terms and in such manner, as it deems

appropriate, Goods or Services similar to those undelivered, and the Bidder shall be liable to the Purchaser for any excess costs for such similar Goods or Services. However, the Bidder shall continue the performance of the contract to the extent not terminated.

- 18) Price shall be inclusive of all freight, forwarding, transit insurance and installation charges.
- 19) Prices shall be inclusive of Excise Duties. The prices shall strictly be submitted in the given format. Quoted prices shall be without C.S.T. and VAT. The tax components like C.S.T. & VAT as applicable shall be mentioned separately in the respective columns.
- 20) Modification and Withdrawal of Bids
 - 20.1 No bid will be allowed to be modified subsequent to the final submission of bid.
 - 20.2 No bid will be allowed to be withdrawn in the interval between the deadline for submission of bids and the expiry of the bid validity. Withdrawal of a bid during this interval will result in the forfeiture of bidder's E.M.D.
- 21) Bids will be opened with the buyer's private digital key in the presence of Bidder's representatives, who choose to attend. The Bidder's representatives who will be present shall sign a register/attendance sheet evidencing their attendance. The representative will be held responsible for all commitments made on behalf of the bidder and that will be considered valid for all further dealings related to this bid process. In the absence of the bidder(s), the Tender Committee may choose to open the bids as per the prescribed schedule.
- 22) The Bidder's names, Bid modifications or withdrawals, discounts and the presence or absence of relevant E.M.D. and such other details as GIL/GOG officer(s) at their discretion, may consider appropriate, will be announced at the opening.
- 23) **Evaluation of the Bids:**
 - 23.1 **After the closing time of submission, GIL committee will open the Technical Bids of the bidders and verify the submission of Bid Processing Fees & EMD as per terms and conditions laid down in the bid document.**
 - 23.2 **The Technical Evaluation will be carried out of the responsive bids. If required bidder will have to arrange the demo of the quoted model during the time of technical evaluation. The financial bid of the technically qualified bidders will be opened and financially L1 bidder will be decided from the sum total of prices (without tax) for all line items (with 5 years Warranty & support), GIL may negotiate the prices with L1 Bidder, under each item/head offered by Bidder.**
- 24) Inspection will be done at customer sites or at GIL office as decided by GIL. Any deviation found in the specification of the produced goods (Routers) from the bid specification will lead to the cancellation of the order, forfeiture of **EMD\PBG** and prohibition in the participation in the future purchase of Government of Gujarat. GIL/GoG will not be responsible for any time delay which may arise due to any deviation from the bid technical specification found at the time of inspection and the bidder has to deliver and install the ordered goods within prescribed time limit. At the time of inspection, Bidder is required to produce OEM's confirmation on OEM's Letter head with Sr. nos. of Equipment for back to back warranty support as per tender terms & conditions.
- 25) The Purchaser's right to inspect, test and, where necessary, reject the Goods after the Goods arrival at Customer Site shall in no way be limited or waived by reason of the Goods having previously been inspected, tested and passed by the Purchaser or its representative prior to the Goods shipment.
- 26) **Delivery & Installation:** Within **4 weeks** from the date of confirmed purchase order.
- 27) Bid validity will be of **180 days** from the date of the bid submission. A bid valid for shorter period shall be rejected as non-responsive.
- 28) **Penalty Clause:**
 - LD/ penalty for delay shall be levied at 0.5% per week or part thereof for the late delivery/undelivered portion of the equipment with a maximum cap of 10% of the late delivery/undelivered portion of the value of work order.
 - Delay beyond 10 weeks may lead to termination of the contract. In such a case the Performance Bank Guarantee of the bidder will be forfeited.

- In case, the selected bidder does not supply the ordered items for any reason, the selected bidder will be liable to pay the difference of amount at which the purchaser may purchase the said item from other bidder/source to the purchaser. In case, bidder is not providing satisfactory support & doing unwarranted delay in providing warranty support, Government offices reserves right to repair the equipment at risk & cost of the bidder.

29) **Operational/Warranty period Penalty:**

- During warranty period, if the complaint is not resolved within 24 hours of the logging of the complaint, the penalty of Rs. 500 per day per faulty Router will be levied. However, if the complaint(s) not resolved within 7 days then from 8th day to 14th day, penalty would be levied @ 150% and from 15th day onwards penalty @ 200% of the above rates would be levied. The amount of penalty will be recovered from the Performance bank guarantee during warranty period.
- It is expected the average downtime of the item (system) will be less than half the maximum downtime. In case an item is not usable beyond the stipulated maximum downtime the bidder will be required to arrange for an immediate replacement of the same till it is repaired. Failure to arrange for the immediate repair/replacement will be liable for penalty of Rs. 500 per day for Router. The amount of penalty will be recovered from the Performance bank guarantee during warranty period.
- Successful bidder will have to submit the Performance Bank Guarantee @ 10% of total order value for the duration of (for warranty period + extra 3 months) as per bid requirements. In case of any penalty claimed from the submitted PBG during the contract period, the successful bidder is required to submit the additional PBG of the amount equal to the penalty claimed for the duration up to the validity of original Bank Guarantee. For example, "X" amount of penalty will be claimed during the 5th month of contract period, then bidder is required to submit the additional PBG of "X" amount for the period of 58 months i.e. 63 months - 5 months

30) **OEM Warranty: 5 Years from the date of Successful FAT**

31) **Payment:** Payment for Goods and Services shall be made by GIL in Indian Rupees as per the below conditions:

31.1 No advance payment will be made.

31.2 80% payment after successful delivery of the ordered goods.

31.3 20% payment after installation, Commissioning and successful FAT of the supplied goods.

32) GIL reserves the right to change any bid condition of any item even after inviting the bids, with/without prior notification.

33) GIL's Right to accept or reject any or all Bids - GIL reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to awarding the Contracts, without thereby incurring any liability to the Bidder or bidders or any obligation to inform the Bidder or bidders of the grounds for such decision.

34) All correction/addition/deletion shall require authorized countersign.

35) **Limitation of Vendor's Liability:** Selected agency's cumulative liability for its obligations under the contract shall not exceed the value of the charges payable by the GISL/GIL within the remaining duration of the contract term from the day claim is raised and selected agency shall not be liable for incidental, consequential, or indirect damages including loss of profit or saving.

36) Force Majeure Shall mean and be limited to the following:

a) War / hostilities

b) Riot or Civil commotion

c) Earthquake, flood, tempest, lightening or other natural physical disaster.

d) Restrictions imposed by the Government or other statutory bodies which prevents or delays the execution of the order by the BIDDER.

The BIDDER shall advise GIL by a registered letter duly certified by the local statutory authorities, the beginning and end of the above causes of delay within seven (7) days of the occurrence and

cessation of such Force Majeure Conditions. In the event of delay lasting over two months, if arising out of causes of Force Majeure, GIL reserves the right to cancel the order.

Delivery & Installation period may be extended due to circumstances relating to Force Majeure by the GIL. Bidder shall not claim any further extension for delivery & installation. GIL/GoG shall not be liable to pay extra costs under any circumstances.

The BIDDER shall categorically specify the extent of Force Majeure conditions prevalent in their works at the time of submitting the bid and whether the same have been taken in to consideration or not in their bids. In the event of any Force Majeure cause, the BIDDER shall not be liable for delay in performing their obligations under this bid and the delivery dates can be extended to the BIDDER without being subject to price reduction for delayed delivered, as stated elsewhere.

It will be prerogative of GIL to take the decision on force majeure conditions and GIL decision will be binding to the bidder.

- 37) The rates quoted by bidder should be valid for 180 days from the date of financial bid opening. Department will place the order of routers as & when required during the validity of bid. If required, bid validity may be extended for further period from the date of expiry of bid validity in consultation with the successful bidder.
- 38) The Clarifications must be submitted in writing at GIL at least 5 days before the submission date. Thereafter the clarifications received from the bidders will not be entertained.
- 39) **If required, GIL may extend the bid validity for further period from the date of expiry of bid validity in consultation with the successful bidder.**
- 40) Your bid should be submitted on website <https://gil.nprocure.com> on or before **1500 Hours, 21/03/2017.**

Proposals after due time period will not be accepted.

The Technical Bids will be opened on **21/03/2017. at 1700 Hours at GIL, Block No. 1, 8th Floor, Udyog Bhavan**, in the presence of the committee members and representatives of the bidders, who have submitted valid bids.
