### **SECTION 1**

#### **Eligibility Criteria for the Bidder:**

- 1. The bidder should have a total sum of turnover of Rs. 5 Crore (Minimum) in the last three financial years as on 31<sup>st</sup> March 2019. The copies of Audited Annual Accounts/Balance Sheet along with Profit & Loss Account and CA Certified Statement for last three financial years as on 31<sup>st</sup> March 2019 shall be attached along with the bid. (Form no. E-1). In Case of Unaudited Balance sheet for the Financial year 18-19, provisional CA certificate is allowed.
- 2. The bidder should have one office in Gujarat. Please upload the copies of any two of the following: Property Tax Bill of last year / Electricity Bills of last one year / Telephone Bills of last one year / VAT Registration / CST Registration / Valid Lease Agreement. (Form no. E-2). In case, bidder does not have office in Gujarat, bidder should give undertaking to open office in Gujarat within 45 days from the date of purchase order.
- 3. The bidder should be valid Certifying Authorities (CA) license holder issued by CCA, MeitY-GoI <u>OR</u>
  Authorized Dealer / Distributor of Certifying Authorities (CA) to quote in this bid. License Copy or copy of Authorization Letter (in case of distributor/dealer) issued by CA to be submitted.
- 4. No consortium will be allowed. The bidder must meet all the eligibility criteria by self. Bidders undertaking should be submitted.
- 5. Bidder should not be blacklisted/debarred by any Ministry of Government of India or by any State Government of India or any of the Government PSUs at the time of bidding. Self-Declaration / Certificate / affidavit mentioning that the Bidder is not blacklisted/debarred as per the clause should be submitted.
- 6. The bidder should have a back-end support agreement/arrangement for services including supply of USB Token etc. with the Original Equipment Manufacturers (OEMs) which includes the post-sales support activities for the entire project period. The OEM undertaking letter should be submitted along with the bid.

### **SECTION 2**

#### **Scope of Work:**

Panchayat, Rural Housing and Rural Development Department, Government of Gujarat is in requirements of Digital Signature Certificate (Signing & Encryption) & USB Token for their application i.e. "Panchayati Raj Institutions Accounting Software - PRIASoft (<a href="https://accountingonline.gov.in/">https://accountingonline.gov.in/</a>)" or "PFMS - Public Financial Management System (https://pfms.nic.in/)" for digital signing.

SI (System Integrator) shall be responsible for the following scope of services and shall be the Single Point of responsibility for the end user during contract period.:

#### 1 Supply Scope:

- a. The application forms have to be collected by the bidder from the respective Taluka office of purchasing Government Department offices across the Gujarat State. Bidder may need to visit respective offices more than once for collection of the same.
- b. The DSC has to be issued and activated within 10 working days of collection of duly filled forms, subject to successful acceptance of the supporting KYC documents as required by CA.
- c. The SI has to carry out enrolment, installation, configuration, testing at each end-user office/ location in co-ordination with purchasing department.
- d. **Training**: Successful bidder has to arrange two operational trainings with the gap of minimum 7 days on DSC usage in co-ordination with purchasing department. Training will be scheduled at each Taluka.
- e. Tenderer will provide the space, table & chair only for training. Rest items will be taken care by bidder.
- f. Digital Signature Certificate with services for the installation & configuration at each location with support.
- g. User Manuals to use the DSC is required to prepare in Gujarati Language and handover to Panchayat Department for their approval. Successful Bidder will have to distribute the approved training/operation manual (hard copies) to end-user at the time of training.
- h. SI has to collaborate with application provider (NIC, GoI) to ensure that the proposed device is working properly with the application (which is running on Java platform) as per requirement and deliver the performance metrics of response time.
- i. USB Token for DSC should be FIPS Certified considering security standards as per CCA guidelines.

#### 2 Services Scope:

- a. The Integration of the Digital signature in Application will be done by Application Developer. However, bidder is responsible to install the DSC at village level along with all necessary driver(s), settings and compatible with all major browsers (i.e. latest and below 2 of latest version of Internet Expoler, Google Chrome & Mozila Firefox etc.) for DSC.
- b. Successful bidder will provide required assistance during DSC registration process (if required) with Application.
- c. Bidder shall be responsible for completion of prerequisite requirements before issuing USB tokens. (Purchaser would provide the list of users with their credentials only.)
- d. Delivery of USB tokens and Training to users on the use of digital signatures.
- e. Bidder is responsible to provide new DSC including USB token at free of cost during contract period in case of hardware corruption, malfunctioning, physical damages etc. except USB token misplace/ theft.
- f. The Successful bidder has to provide centralized Helpdesk contact number along with escalation matrix for complaint booking and technical assistance.
- g. Provide warranty for digital signature that shall be supplied and installed under this procurement throughout the period of contract.
- h. Digital Signature Certificate should support Window 8 and above Operating systems (64-bit).
- i. Bidder will have to follow guidelines, operation policy, procedure and security policy issued by various authorities from time to time w.r.t to DSC strictly and breach of the any of the policy will liable for action under prevailing laws/rule/regulations.



### **SECTION 3**

#### **General Terms & Conditions:**

- 2. The bid is non-transferable.
- 3. The Bidder may quote DSC from only one CCA licensed CA under the bid. Bidders are required to mention make & model of the product. (Do not write "OEM" against items as bidders are expected to give make & model of the product).
- 4. The successful bidder will have to supply, install, activate, test, & deliver functional training of supplied hardware and software with all required drivers and plugins at end-user location across the Gujarat State.
- 5. If in any case, the quoted Item is not available in the market, the bidder will have to supply Higher Version/replacement of that Item in the quoted cost in the same time duration with prior approval of GIL/Purchaser.
- 6. The Bidder shall bear all the costs associated with the preparation and submission of its bid, and GIL in no case will be responsible or liable for these costs, regardless of conduct or outcome of bidding process.
- 7. The bidder has to upload the compliance letter on its letter head duly signed by the authorized signature & other supporting documents as asked for in the bid in scanned format. Failing to submit the same or non-compliance/deviation from any bid terms and conditions, eligibility criteria or technical specifications may result in rejection of the bid.
- 8. The Bidder has to examine all instructions, forms, terms, conditions and specifications in the bidding documents. - 10. Bid Currency Prices shall be quoted in Indian Rupees only. Payment for the supply of equipments as specified in the agreement shall be made in Indian Rupees only.

- 13. EMD of all unsuccessful bidders would be refunded by GIL within 30 Days after the award of the work to the successful bidder. The EMD submitted of successful bidder would be returned upon submission of Performance Bank Guarantee and signing of contract.
- 14. The EMD may be forfeited at the discretion of GIL, on account of one or more of the following reasons:
  - a. If a Bidder withdraws their Bid during the period of Bid validity.
  - b. If Bidder does not respond to requests for clarification of their Bid

The Successful bidder has to submit Performance Bank Guarantee @ 10 % of total order value within 15 days from the date of issue of Purchase order for the duration of contract period + extra 3 months from any Nationalized Bank including the public sector bank or Private Sector Banks or Commercial Banks or Co-Operative Banks and Rural Banks (operating in India having branch at Ahmedabad/ Gandhinagar) as per the G.R. no. - 17. The Successful Bidder will have to sign the contract upon receiving the confirmed purchase order with the purchaser(s) within 15 working days from the date of confirmed purchase order. (The draft is attached herewith).
- 18. The successful Bidder's E.M.D. will be returned upon the Bidder signing the Contract and furnishing the Performance Bank Guarantee as per bid terms.

#### 19. Termination for Default:

- 19.1. The Purchaser may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Bidder. The bidder will be given notice/cure period of 30 days after that purchaser will terminate the Contract in whole or part after:
  - a) If the bidder fails to deliver any or all of the Goods as per the delivery schedule mentioned in the bid, or within any extension thereof granted by the Purchaser or
  - b) If the Bidder fails to perform any other obligation(s) under the Contract/Purchase order.
  - c) If the Bidder, in the judgment of the Purchaser has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.

#### For the purpose of this clause:

"Corrupt practice" means the offering, giving, receiving or soliciting of anything of value of influence the action of a public official in the procurement process or in contract execution.

- "Fraudulent practice: a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the purchaser, and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the purchaser of the benefits of free and open competition;"
- 19.2. In the event the Purchaser terminates the Contract in whole or in part, pursuant to Clause above, the Purchaser may procure, upon such terms and in such manner, as it deems appropriate, Goods or Services similar to those undelivered, and the Bidder shall be liable to the Purchaser for any excess costs for such similar Goods or Services. However, the Bidder shall continue the performance of the contract to the extent not terminated.
- 20. Price shall be inclusive of all freight, forwarding, transit insurance, installation, warranty and maintenance charges. The prices shall strictly be submitted in the given Price Bid format
- 21. The Quoted prices shall be inclusive of all taxes except GST and have to be mentioned separately in the respective column in the price bid.
- 22. Late Bids: No bidder will be allowed to upload or submit the bid after the bid due date/time.

- 23.3. No bid will be allowed to be withdrawn in the interval between the deadline for submission of bids and the expiry of the bid validity. Withdrawal of a bid during this interval will result in the forfeiture of bidder's E.M.D.

#### 24. Opening of Bid:

#### 26. Evaluation of the Bids:

- 26.1. After the closing time of submission, GIL / GoG committee will verify the submission of Bid Processing Fees & EMD as per bid terms and conditions. The eligibility criteria evaluation will be carried out of the responsive bids. The technical bids of the bidders who are complying with all the eligibility criteria will be opened and evaluated next.
- 26.2. GIL will seek clarifications if required on eligibility & technical section.
- 26.3. The financial bid of the technically qualified bidders will be opened and financially Lowest (L1) bidder will be identified based on the sum total of prices for all line items without tax with warranty and then called for further negotiations if required.

#### 27. Award of Contract:

- 25.1 Award Criteria: The Criteria for selection will be the lowest effective cost for the technically qualified bids.
- 25.2 Contract will be valid for 2 years from the date of issuance of work order.
- 25.3 In case, the lowest bidder (L1) does not accept the award of contract or found to be involved in corrupt and/or fraudulent practices, the next lowest bidder i.e. L2 will be awarded the contract. In such scenario, the L2 bidder has to match the L1 Price and execute the project at the L1 Price for the entire contract duration.
- 28. GIL/Panchayat Department reserves right to perform random inspection and verification of DSC at any location at any point of time. Random Inspection at the sample villages will be carried out by GIL / Panchayat Department for the verification that whether the DSC has been issued and installed properly or not and whether adequate training has been provided or not. Any deviation found in the specification of the produced goods from the bid specification will lead to the cancellation of the order, forfeiture of EMD/PBG and prohibition in the participation in the future purchase of Government of Gujarat. GIL/GoG will not be responsible for any time delay which may arise due to any deviation from the bid technical specification found at the time of inspection and the bidder has to deliver and install the ordered goods within the prescribed time limit. At the time of inspection, bidder is required to produce OEM's confirmation on OEM's letter head for back to back warranty support as per tender terms & conditions.
- 29.
