- 1. If OEM's eligibility is used to comply with Sr. No. 3 of Revised Eligibility Criteria, then OEM must bid as consortium partner along with bidder. The OEM has to be severally & jointly liable for entire project as per the scope mentioned in EoI along with its corrigendum's and a statement of this effect shall be included in the MoU/ Consortium Agreement. Further, in this case except for revise clause no 3, all other eligibility criteria specified earlier needs to be complied by bidder on his own.
- 2. One OEM can bid as a consortium partner with only one bidder only.
