**The eligibility Criteria is as below:**

1. The vendor should be in the business of Data Entry and Scanning for at least three years as on 31<sup>st</sup> March 2019 having experience of Scanning of at least 50 years of old documents of national/state archives or similar institutes, old historical & hand written documents preservation institute, State/Central Govt. Office. Company Incorporation Certificate must be submitted for the same along with copy of work order/client certificate older than three years.
2. The bidder should have handled at least 50 lacs documents in the last two years. Necessary copy of work order / certificates on client letterheads should be submitted as testimonials.
3. The bidder should have completed at least 3 Scanning projects (including Data Entry and retrieval of document) during last five years as on 31<sup>st</sup> March, 2019 with order value of Rs 50 lacs in each. Copy of the work order of the same must be attached.
4. The bidder must have one office in Gujarat. Please upload the copy of any two of the following: Property tax bill/Electricity Bill/Telephone Bill/GST Registration/Lease agreement. **In case, bidder do not have office in Gujarat, bidder should give undertaking to open office in Gujarat within 45 days from the date of empanelment.**
5. The bidder should have ISO 9001:2015 or latest certification for "Data Entry/Scanning/Digitization and related services".
6. Total turnover of the firm should be at least Rs. 5 Crore during the each of last three financial years. (i.e. either 2016-17, 2017-18 & 2018-19). The bidder must attach Statutory Auditor's Certificate Certifying the turnover in each of the last three years. Bidder should have to upload the copies of the audited Balance sheet and profit and loss accounts.
7. The Bidder should not be under a declaration of ineligibility for corrupt and fraudulent practices issued by Government of Gujarat or any of the PSU in the state of Gujarat. Certificate / affidavit mentioning that the Bidder is not currently blacklisted by Government of Gujarat or any of the PSU in the state of Gujarat is due to engagement in any corrupt & fraudulent practices. (Self-Declaration as Annexure-1)
8. Manpower and Machine Required at District Level. The bidders should be in a capacity to provide optimum manpower in machinery at various places to complete project work well in time.

**Note:** Bidders who wish to participate in this bid will have to register on <https://gil.nprocure.com>. Further bidders who wish to participate in online bids will have to procure Digital Certificate as per Information Technology Act 2000 using which they can sign their electronic bids. Bidders can procure the same from (n) code solutions – a division of GNFC Ltd., or any other agency licensed by Controller of Certifying Authority, Govt. of India. Bidders who already have a valid Digital Certificate need not procure a new Digital Certificate.

**The terms and conditions are as follows:**

- 1 The last date of submission of bid on the website <https://gil.nprocure.com> is **1500 Hrs. 05.02.2020. No physical bids will be accepted under normal circumstances.** However, GIL reserves the right to ask the bidders to submit the bid and/or any other documents in physical form.
- 2 The bid is non-transferable.
- 3 **The bidders will have to quote for all 5 divisions (each), bidders have to quote all the divisions compulsory mentioned in the financial bid documents. Bidder will have to consider all the district in a particular division and mentioned in Annexure-A1. L1 in each division will be given work. Incomplete bids will be treated as non-responsive and will be rejected.**
- 4 The bidder will have to setup the required equipment's and related peripherals and carry out necessary integration at various Districts across the Gujarat State.
- 5 The Bidder shall bear all the costs associated with the preparation and submission of its bid, and GIL will in no case will be responsible or liable for these costs, regardless of conduct or outcome of bidding process.
- 6 The bidder has to upload the compliance letter on its letter head duly signed by the authorized signature & other supporting documents as asked for in the bid in scanned format. Failing to submit the same or non-compliance/deviation from any bid terms and conditions, eligibility criteria or technical specifications may result in rejection of the bid.
- 7 The Bidder has to examine all instructions, forms, terms, conditions and specifications in the bidding documents. Failure to furnish all information required by the bidding documents or submission of a bid not substantially responsive to the bidding documents in every respect will be at the Bidder's risk and may result in rejection of its bid.
- 8 Amendment of Bidding Documents (Corrigendum)
  - 8.1 At any time prior to the deadline for submission of bids, GIL may, for any reason, whether its own initiative or in response to the clarification request by a prospective bidder, modify the bidding documents.
  - 8.2 The corrigendum will be published on website <https://gil.nprocure.com> & [www.gil.gujarat.gov.in](http://www.gil.gujarat.gov.in).
  - 8.3 In order to allow prospective bidders reasonable time to take into consideration the amendments while preparing their bids GIL, at its discretion, may extend the deadline for the submission of bids.
- 9 Bid Currency – Prices shall be quoted in Indian Rupees only.
- 10 **The Bidder will have to submit Nonrefundable Bid Processing Fees of Rs. 17,700/- and Earnest Money Deposit (E.M.D.) of Rs. 15,00,000/- in a sealed cover at GIL office with the heading "Bid Processing fees & EMD for the e-Tender No. SWT160120193 for Selection of Agency for Scanning & Digitization of City Survey Records on behalf of Office of the Settlement Commissioner & Directorate of Land Record, Gandhinagar."**
  - ✓ Bid processing fees must be in the form of Demand Draft in the name of "Gujarat Informatics Ltd." payable at Gandhinagar along with the covering letter. Please affix the stamp of your company on the overleaf of demand draft.

- ✓ EMD shall be submitted in the form of **Demand Draft** OR in the form of an **unconditional Bank Guarantee (which should be valid for 12 months from the last date of bid submission)** of All Nationalized Bank including the public sector bank or Private Sector Banks or banks (operating in India having branch at Ahmedabad/ Gandhinagar) as per the G.R. no. **Note:** Failing to submit physical covers of EMD and bid processing fees at GIL on or before **05.02.2020 up to 1500** hours may lead to the rejection of the bid.

- 11 In case of non-receipt of Bid Processing fees & EMD as mentioned above within prescribed time the bid will be rejected by GIL as non-responsive.
- 12 Unsuccessful/disqualified bidder's E.M.D. will be returned as promptly as possible but not later than 15 days after the expiration of the period of bid validity OR upon the successful Bidder signing the Contract, and furnishing the Performance Bank Guarantee @ 10% of the total order value as prescribed by GIL, whichever is earlier.
- 13 In exceptional circumstances, GIL/SCNDR may solicit the Bidder's consent to an extension of the period of validity of the project work. The request and the responses thereto shall be made in writing. A Bidder may refuse the request without forfeiting its E.M.D. A Bidder granting the request will not be permitted to modify its bid.
- 14 The Successful bidder has to submit Performance Bank Guarantee @ 10% of total order value within 15 days from the date of issue of Purchase order (for period of 3 months) All Nationalized Bank including the public sector bank or Private Sector Banks or banks (operating in India having branch at Ahmedabad/ Gandhinagar) as per the G.R. no. EMD/10/2018/18/DMO dated 16.04.2018 ([http://www.gil.gujarat.gov.in/grs/DMO\\_2173\\_16\\_Apr\\_2018\\_714.pdf](http://www.gil.gujarat.gov.in/grs/DMO_2173_16_Apr_2018_714.pdf)) issued by Finance Department or further instruction issued by Finance department time to time. (The draft of Performance Bank Guarantee is attached herewith).
- 15 Successful bidders will have to sign the contract upon receiving the Purchase order with the purchaser(s) within 15 working days from the date of Purchase order. (The draft of the Contract form is attached herewith)
- 16 The successful Bidder's E.M.D. will be returned upon the Bidder signing the Contract, furnishing the Performance Bank Guarantee @ 10% of the total order value.
- 17 If the successful bidder fails to submit the Performance Bank Guarantee & sign the Contract Form within prescribed time limit, the EMD of the successful bidder will be forfeited. GIL also reserves the right to blacklist such bidder from participating in future tenders if sufficient cause exists."
- 18 The E.M.D. may be forfeited:
  - (a) if a Bidder withdraws its bid during the period of bid validity
  - (b) In case of a successful Bidder, if the Bidder fails:
    - (i) To sign the Contract as mentioned above or

- (ii) To furnish performance bank guarantee as mentioned above or
- (iii) If the bidder is found to be involved in fraudulent practices.
- (iv) If the bidder fails to submit the copy of purchase order & acceptance thereof.
- (v) If the successful bidder fails to submit the Performance Bank Guarantee & sign the Contract Form within prescribed time limit, the EMD of the successful bidder will be forfeited. GIL also reserves the right to blacklist such bidder from participating in future tenders if sufficient cause exists.

19 Termination for Default

19.1 The Purchaser may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Bidder, terminate the Contract in whole or part:

- a) if the bidder fails to deliver any or all of the Goods & services within specified days from the date of purchase order, or within any extension thereof granted by the Purchaser or
- b) if the Bidder fails to perform any obligation(s) under the Contract/Purchase order.
- c) If the Bidder, in the judgment of the Purchaser has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.

For the purpose of this clause:

“Corrupt practice” means the offering, giving, receiving or soliciting of anything of value of influence the action of a public official in the procurement process or in contract execution.

“fraudulent practice: a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the purchaser, and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the purchaser of the benefits of free and open competition;”

19.2 In the event the Purchaser terminates the Contract in whole or in part, pursuant to Clause 19.1 above, the Purchaser may procure, upon such terms and in such manner, as it deems appropriate, Goods or Services similar to those undelivered, and the Bidder shall be liable to the Purchaser for any excess costs for such similar Goods or Services. However, the Bidder shall continue the performance of the Contract to the extent not terminated.

20 Price shall be inclusive of all freight, forwarding, transit insurance and installation charges.

21 Prices shall be in Indian Rupees. The prices shall strictly be submitted in the given format. The tax (GST) components as applicable shall be mentioned separately in the respective columns.

22 Late Bids – The bidder will not be able to submit the bid after final submission date and time.

23 Modification and Withdrawal of Bids

23.1 No bids will be allowed to be modified subsequent to the final submission of bids.

23.2 No bid will allowed to be withdrawn in the interval between the deadline for submission of bids and the expiry of the bid validity. Withdrawal of a bid during this interval will result in the forfeiture of bidder's E.M.D.

- 24 Bids will be opened in the presence of Bidder's representatives, who choose to attend. The Bidder's representatives who are present shall sign a register/attendance sheet evidencing their attendance. The representative will be held responsible for all commitments made on behalf of the bidder and that will be considered valid for all further dealings related to this tender process. In the absence of the bidder(s), the tender committee may choose to open the bids as per the prescribed schedule.
- 25 The Bidder's names, Bid modifications or withdrawals, discounts and the presence or absence of relevant E.M.D. and such other details as GIL/GOG officer(s) at their discretion, may consider appropriate, will be announced at the opening.
- 26 **Evaluation of the bids:** After the closing time of submission, GIL/SCNDLR committee will verify the submission of Bid Processing Fees & EMD as per bid terms and conditions. The eligibility criteria evaluation will be carried out of the responsive bids. The bidders who are complying with all the eligibility criteria will be opened and evaluated next. The financial bids of the eligible & qualified bidders will be opened and Successful bidder (i.e. L1 bidder) will be decided based on the Division wise lowest quoted rates without tax as mentioned in the financial bid section and then called for further negotiations if required. There may be a possibility to get different L1 bidder for different Division.
- 27 The Department reserves the rights to empanel one or more qualified bidders for respective divisions, subject to their matching with the L1 price.
- 28 In case of successful bidder is found in breach of any condition(s) of bid or supply order/work order, at any stage during the course of Contract period, the legal action as per rules/laws, shall be initiated against the empanelled bidder and EMD/PBG shall be forfeited, besides debarring and blacklisting the bidder concerned for the time period as decided by Govt., for further dealings with GoG.
- 29 If the successful bidder fails to execute the work, agency shall be de-barred for five years and reaming work will be completed to next lower rate bidder and cost would bare by failure agency.
- 30 Bids shall be valid for **1 year** after the date of financial bid opening. For any more such type of scanning work in future, the same rate quoted in the financial bid will apply for 1(One) year from the completion of date of work order's date. A bid valid for a shorter period shall be rejected as non-responsive. If required, GIL may extend the bid validity for further period from the date of expiry of bid validity in consultation with the successful bidder.
- 31 Incomplete bids will be treated as non-responsive and will be rejected.
- 32 **Penalty Clause for delay:** As mentioned in the section-II.
- 33 Successful bidder should submit the Performance Bank Guarantee @ 10% of total order value for the duration of (for three months) as per bid requirements. In any case, bidder is required to maintain 10% PBG at all time during the period of contract. In case of any penalty claimed from the submitted PBG during the contract period, the successful bidder is required to submit the additional PBG of the amount equal to the penalty claimed for the duration up to the validity of original Bank Guarantee.

- 34 **Payment:** As mentioned in the section-I para 17(2) and section-II para 9.
- 35 GIL reserves the right to change any bid condition of any item even after inviting the bids, with/without prior notification.
- 36 GIL's Right to accept any Bid and to reject any or all Bids – GIL reserve the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to awarding the Contracts, without thereby incurring any liability to the affected Bidder or bidders or any obligation to inform the affected Bidder or bidders of the grounds for such decision.
- 37 The quantity mentioned in this Bid is as per indents received by GIL. During the validity of Bid, any Govt. Dept can place purchase order for any item at finalized rates under this bid, hence successful vendor will have to accept purchase orders during the validity of Bid period.
- 38 The tendered quantities are estimated based on the receipt of the requirement from various Government offices. The quantities may decrease bid quantity or increase the bid quantity at the time of finalization actual scanning work and certified by local offices. Depending upon the change in the requirements/grants available with the purchaser(s), which shall be binding to the bidder.
- 39 All correction/addition/deletion shall require authorized countersign.
- 40 Limitation of Vendor's Liability: Selected agency's liability shall be capped 100% of contract value plus other measures if defaults and QoS failures continue.
- 41 Force Majeure Shall mean and be limited to the following:
- a) War / hostilities
  - b) Riot or Civil commotion
  - c) Earthquake, flood, tempest, lightening or other natural physical disaster.
  - d) Restrictions imposed by the Government or other statutory bodies which prevents or delays the execution of the order by the BIDDER.

The BIDDER shall advise GIL by a registered letter duly certified by the local statutory authorities, the beginning and end of the above causes of delay within seven (7) days of the occurrence and cessation of such Force Majeure Conditions. In the event of delay lasting over two months, if arising out of causes of Force Majeure, GIL reserves the right to cancel the order.

Completion period may be extended to circumstances relating to Force Majeure by the GIL. Bidder shall not claim any further extension for completion of work. GIL/GoG shall not be liable to pay extra costs under any conditions.

The BIDDER shall categorically specify the extent of Force Majeure conditions prevalent in their works at the time of submitting their bid and whether the same have been taken in to consideration or not in their quotations. In the event of any Force Majeure cause, the BIDDER shall not be liable for delays in performing their obligations under this order and the delivery dates can be extended to the BIDDER without being subject to price reduction for delayed delivered, as stated elsewhere.

It will be prerogative of GIL/GoG to take the decision on force major conditions and GIL/GoG decision will be binding to the bidder.

# SECTION I

## INSTRUCTIONS TO BIDDERS

### INTRODUCTION

Office of the Settlement Commissioner & Directorate of Land Record, Gandhinagar wants to scan all the records of city survey offices like SI (Self Index) cases, Enquiry registers, Mutation registers digitize and retrieve, Plot book, "Gunakar book" and other allied registers related to city survey are very important documents. All the records mentioned above are prepared before 100 years. Therefore, it is necessary to be careful while scanning those records because those records are torn and brittle. Five Division/District Offices with Records center at Ahmedabad, Bhavnagar, Vadodara, Surat & Rajkot.

Initial City surveys were carried out in Surat city in 1821 and in Ahmedabad city in 1824. However, these surveys were a practical failure for the reasons that they were not accompanied by any definite settlement of rights nor were any provisions made for the future upkeep of the maps and records.

In the year 1863, the Collector of Ahmedabad, Mr. T. C. Hope, called the attention of Government regarding prosperity of the city is such as to cause a great demand for building sites, builders have very doubtful titles or often none at all, cases of encroachment take up a good deal of time of both revenue and municipal authorities and can rarely be decided satisfactorily, proposal was accepted and Ahmedabad city survey carried out in 1963.

Then after the proposals made by Mr. T. C. Hope were sanctioned and the survey commenced in Ahmedabad city in 1963. Two years later the Survey was extended to Surat, Valsad and Bharuch and to Rander. At the beginning of the year 1867 an important Code of Rules with reference to the work of Enquiry into Title, drawn up by Mr. Hope, was sanctioned by Government Resolution No 862 dated 28<sup>th</sup> February 1867. These rules formed the basis of city surveys of Bharuch, Ahmedabad, Valsad and Rander. They became obsolete on the passing of Act IV of 1868.

**Objective.** The objectives of city surveys are threefold and maybe described as administrative, fiscal and legal.

- (1) The administrative objectives are to provide maps having particular details of houses, roads, open space etc. which can be useful for administrative purposes such as urban planning or land acquisition for water supply, drainage line, gas line, roads etc.
- (2) The fiscal objectives are to ascertain the revenue due from land and to protect public land against encroachment and wholesale of furtive appropriation.
- (3) The legal objectives are to clear all titles to existing holdings, to prevent litigations between land holders and local bodies

**Coverage of city survey in the state:** As per Chapter 10A of Gujarat Land Revenue code 1879, It is equally important like Village Form No. 7 and 12 for agricultural land to prepare a record of rights of unmeasured properties land is potential for City Survey work.

## Description of Records to be Scan

### **1. Inquiry register**

The Inquiry Register is maintained at the time of Introduction of City survey. This register consists of a total of 16 columns, containing the names of the panchayat/municipal corporation, area and occupant, respectively, running by the surveyor who measured the columns from 1 to 5. Column No. 5 to 16 entitles the inquiry officer to fill the vacancy while securing the rights. In Column No. 13, the authority of the right inquiry officer is written on the evidence and answer of the applicant. Column No. 6, 7 and 13 rights are to be filled by the particular inquiry officer. The register can be "A-1" "A-2" "A-3" "A-4" and "Legal" Size in one page. Each page contains details of approximately five properties. Inquiry Register is prepared on Measurement Seat Wise and multiple Measurement Seat are also included in one register. This register is a permanent type of record and after this register is ready no changes / corrections are captured in this register.

An estimated total of 7027 inquiry register of all City survey offices. Scanning of 10,65,393 pages of A / 1-18,677, A / 2-83,855, A / 3-7,38,093, A / 4-3,167, Legal-2,21,601.

### **2. Gunakar book**

The Gunakar book consist of calculation of area all the properties in this register. The register can be "A-1" "A-2" "A-3" "A-4" and Legal Size in one page. This register shows the seat number, chalta number, City survey number, estimated figure and its multiples. This register is a permanent record and after this register is ready there are no changes / corrections. It may consist one or more properties Gunakar book area in one page.

An estimated total of 10,387 Gunakar books of all City survey offices. Scanning a total of 11,15,479 pages of A / 2-19,470, A / 3-51,363, A / 4-3,29,517, Legal-7,15,129.

### **3. Plot Book**

This Plot book has plot wise plotted along with the approximate figure size of the properties measured at the time of measurement. The register can be "A-1" "A-2" "A-3" "A-4" and Legal Size in one page. This page does not have any exact number of properties on each page, but each page has different number of properties. The Plot book page lists the seat number, Chalata number and City survey number of the property. This register is a permanent record and after this register is ready there are no changes/corrections.

An estimated total of 5,005 Plot book of all City survey offices. Scanning a total of 2,44,758 pages of A / 1-1,402, A / 2-9,622, A / 3-4,2800, A / 4-24,837, Legal-1,66,097.

#### **4. Mutation Register**

After Hakchoksi, changes in properties are maintained in mutation registers. There are a total of 1 to 8 columns in this register. It is also called as record of right register. This register contains the details as per the details entered in the property card. All changes in property are noted in this register and this register is updated by mutation entries. This Register is digitally maintained since 1/1/2017, when online mutation of all properties are being entered in the State. There are currently no changes made to this register. The register can be "A-1" "A-2" "A-3" "A-4" and Legal Size in one page. This register is corrected with property card by mutation entry number.

An estimated total of 8562 Mutation registers of all City survey offices. Scanning a total of 10,74,534 pages of A / 1-18, A / 2-7,557, A / 3-92,101, A / 4-1,29,979, Legal-8,44,879.

#### **5. S.I. CASE (SELF INDEX)**

The S.I. Case is not a register but the files are prepared by collecting the evidence obtained from the property holders at Hakchoksi time, which is called the SELF INDEX case. S.I. Case has first Index page enlisting the documents attached in files and no of pages according to mutation entries in property cards called "Jacket form" Jacket form is a list of documents of a particular city survey number. The S.I. Case file a collection of Property Holder's evidence obtained from the property at a particular time is called a Self-Index. The addition of documents in S.I. case will be followed by the change of property Holder name in mutation register as well as in property cards of a particular city survey number. The S.I. case has a jacket form, the details of all the mutation entry in that form are noted on page no. The S.I. Cases can be "A-1" "A-2" "A-3" "A-4" and "Legal" Size in one page.

An estimated total of 33,67,853 S.I. cases of City survey offices. Scanning a Total of 12,31,16,406 pages of A / 1-29,399, A / 2-1,59,352, A / 3-20,04,478, A/4-4,45,89,708, Legal-7,63,33,469.

## Scope of Work

It will be the responsibility of the agency: -

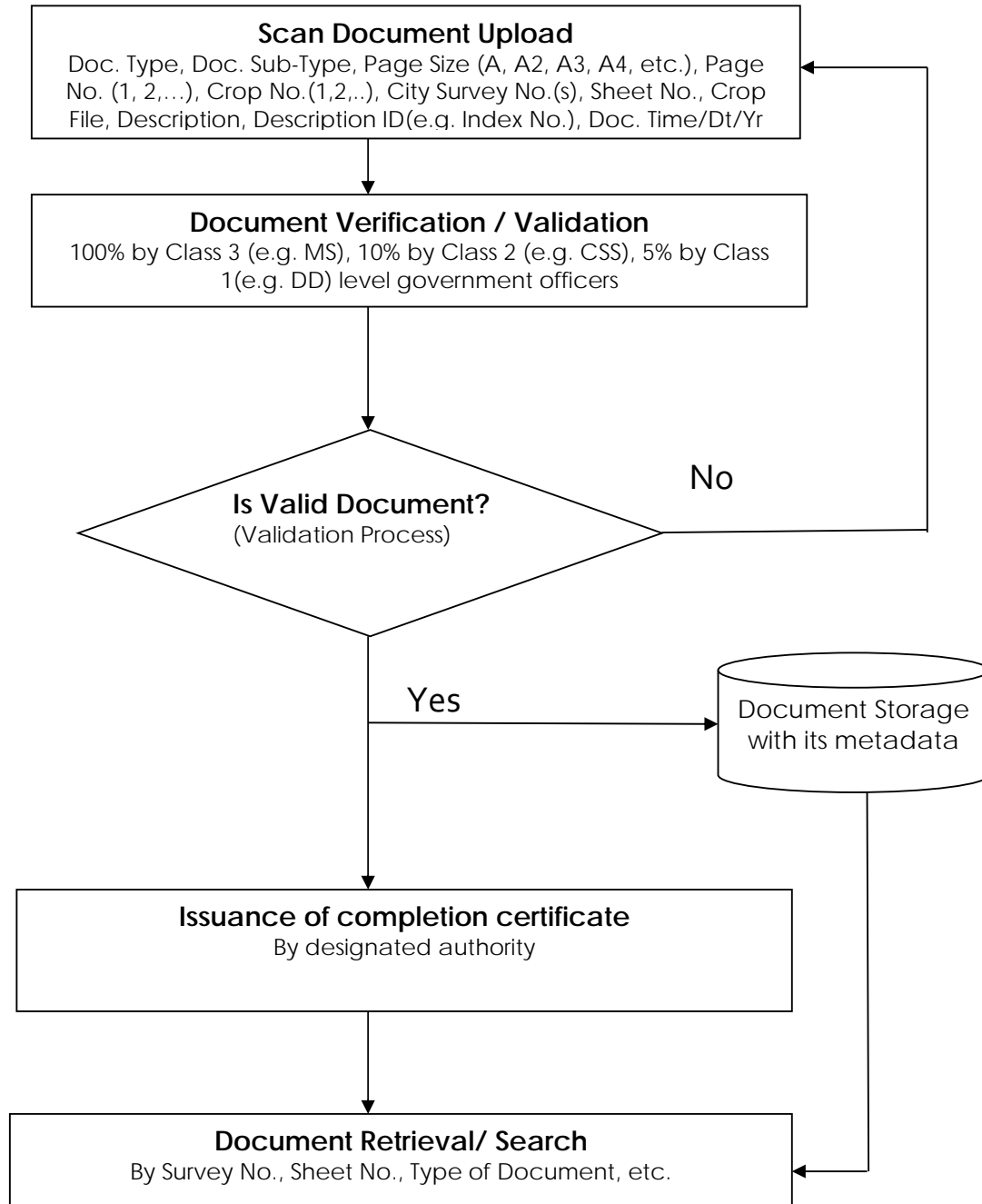
1. To work at the district offices of state of Gujarat. The list of offices with details are mentioned at **Annexure A1**. The successful bidder shall work during office hrs.
2. Bring all the requisite Hardware and Peripherals as mentioned in this document required to meet the desired service standards at their own cost.
3. Service Provider shall do the pagination of each file before starting scanning & after scanning the document SI has to crop the document as per the requirement of the Dept.. It shall be part of scanning work. Meta data entry with concern scan document upload in software module will be provided by Department is also the part of scanning work. No extra charge for the same will be given to the service provider.
4. Bidder may not be allowed Unbinding of bounded volumes but the bidder will have to use proper Scanner for the work. Also, automatic page flipping machines and scanning by digital cameras & mobile phones will not be allowed.
5. Service Provider will have to Scan the Documents in min. resolution of 300 dpi and submit the same in Hard Disk along with the retrieval software provided by department. Resolution may vary according to the document condition. They have to submit indexed print out of and PDF file of index the files scanned. In future there may be decided to upload the document images on the web, so the successful bidder has to work considering the same. The bidder will have to carry out meta data entry and uploading of files for at file level for retrieval.
6. All the scanning will be done in original color of the document which will be converted in color & black & white. Scanning will be done in true 300 dpi optical resolution, where readability is poor the vendor should be prepared to go for 600 dpi or even higher resolution.
7. The Service Provider will be handed over the documents in a batch in prescribed flow chart and he will cross-check this information and will prepare a list containing discrepancies, as well as rectify the same.
8. The Service Provider will scan all the documents and will carry out Quality Checks in order to ensure that the scanning quality is good and the pages are perfectly scanned. (i.e. 5% of the Quality Check of the scanned document will be verified randomly by Department Class-1 Officer, 100% of the Quality Check of the scanned document will be verified randomly by Department Class-3 Officer, 15% of the Quality Check of the scanned document will be

verified randomly by Department Class-2 Officer). During verification, if any errors found then vendor will have to rescan upload as direction given by local officer without any additional cost

9. Pages of the document may be stapled or tied, the Service Provider will not be allowed to unstapled/untie for the purpose of scanning.
10. The format of the scan document will be in PDF only. Scanned images with meta data and upload it of these documents will have to be converted into PDF files.
11. The PDF files of the scanned documents will have to be stored in the data base & written on USB Hard Disk. The concerned Data files relating to these documents will also have to be written on the same USB Hard Disk for which the document files are. Further, USB Hard Disk will have to have the run-time of the software, which will enable the quick search and viewing/printing of the database as also the PDF files. The Service Provider will have to **provide two sets of USB Hard Disk separately for color and Black & white image to each office.**
12. SP needs to create the database/index for the scanned documents so that search engine could handle the search of particular scanned document. Also the said scanned documents would be uploaded on website so index should be database/index should be prepared accordingly. The indexing of data should be in Unicode. The data entry software for scanned document should be prepared in consultation with the Settlement Commissioner & Directorate of Land Record Office.
13. The software provided by SCNDLR office be capable of quick search, retrieval, viewing and printing of the data-base and PDF files as well as physical location, Class no. of the file. The Retrieval software should be capable of searching within image-PDF files (searchable PDF Files). All rights of the software will be reserved with Settlement Commissioner & Directorate of Land Record Office.
14. SP should responsible for Meta data entry will be carried out in NIC software with below mentioned field. There is a possibility of adding more fields and SP may need to do entry in additional fields without any extra cost.

15. No Mobile or camera image or picture but only specific Scanning device (except mobile or camera) should be used for scanning documents. If such documents found scanned in such manner, will not be accepted and scanning and uploading will have to made by vendor again.
16. Agency cannot sublet the work to other agencies. If found, heavy penalty and blacklisting of company will be done.
17. work under city survey surveillance CCTV camera will be carried out.
  1. Preparation of work calendar and daily work progress. for all activities and the assigned work should be reported
  2. 80% Payment will be based on per 50,000 documents scanning data entry verification and batch wise will be done 20% payment will be done after total completion of the project work.
  3. Payment on PDF page number of PDF pages and number of cropped pages. System generated work done certificate.
18. The Created PDF file should be searchable using the above mentioned fields.
19. The Documents may be anywhere from 55 to 200 years old. All the documents are very important. The Documents may have different size. Proper care should also be taken while scanning for every document. The successful bidder has to provide security measures while preparing HDDs that no one can change the content of the documents.
20. Bidder needs to upload all the scanned documents with Metadata, in software provided by NIC/organization assigned by Settlement Commissioner or GIL/DST. The bidder has to ensure that the scanned documents with Metadata uploaded properly in software provided by NIC.
21. The Documents are very old and acidic. Some papers may be brittle and fragile. So additional care should also be taken to handle while the process of scanning.
22. Total Approximate Volume of all the district offices (Ahmedabad, Surat, Rajkot, Vadodara and Bhavnagar) is as mentioned in **Annexure A1**. The volume will be increased/decreased by 30%.

**SECTION II:**

**GENERAL CONDITIONS OF CONTRACT**

**1. Definitions**

In this Contract, the following terms shall be interpreted as indicated:

- 1) "The Contract" means the agreement entered into between Settlement Commissioner & Directorate of Land Records. and the Service Provider, as recorded in the Contract Form Signed by the parties, including all the attachments and appendices thereto and all documents incorporated by reference therein;
- 2) "Bidder" means any agency that is participating in the tender process.
- 3) "Service Provider" means any agency who is a successful bidder and to whom the contract has been awarded.
- 4) "The Contract Price" means the price payable to the Service Provider under the Contract for the full and proper performance of its contractual obligations;
- 5) "The Goods" means all the equipment, machinery and /or other materials which the Service Provider is required to supply to Settlement Commissioner & Directorate of Land Records under the Contract.
- 6) "Document" means Mutation Register, Inquiry Register, S.I. Cases, Gunakar Book, Plot Book, files, maps, photographs, registers, manuscripts, Gazettes, Books etc.
- 7) "Paper Size" means it may be A<sub>4</sub>, A<sub>3</sub>, A<sub>2</sub>, A<sub>1</sub> standard paper size of the document.
- 8) "Page number" mean one side of the paper.
- 9) "page" means both side of the the paper.
- 10) "Services" means services ancillary to the supply of the Goods, such as transportation and insurance and any other incidental services, such as installation, commissioning, provision of technical assistance, training and other obligations of the Service Provider covered under the Contract;
- 11) "The Project Site", wherever applicable, means the place or places where the work is to be executed.
- 12) "Day" means a working day.
- 13) "Unit" means one single office where the entire set up has to be provided.
- 14) "Office Completeness" means the site should be complete in all respects i.e.
  - ◆ Hardware is supplied, installed and commissioned
  - ◆ Requisite Software is installed
  - ◆ Requisite Application Software is installed.
  - ◆ Connectivity setup is established.
  - ◆ Requisite Manpower is deployed

- ◆ The entire setup as defined in scope of work has become functional & the transactions can be done on computers.

15) "Maintenance" means agency will take for below mentioned subject

- Taking care of the machine
- Changing the Spares when they become faulty
- Locate, remove, and repair technical faults.
- Identify Software related problems such as run time error viruses etc. & reload the machines with Software
- Maintaining up time of at least 95%
- Housekeeping of all Hardware
- Ensuring continuous power supply to all machines during working hours.
- Any other task to be performed to keep the system functional.

#### 16) Performance Standards

This factor incorporates the maintenance standards as defined below:

##### **Service Level Standards: -**

The agency has to meet the service level norms failing which the contract is liable to get cancelled.

- a) Install high quality hardware and peripherals at all sites to ensure minimum downtime.
- b) Provide skilled and efficient manpower to attain maximum production.
- c) Provide quality consumables like HDDs, Paper, Toners, Tapes, external Hard disks etc.
- d) Absolutely avoid usage of low quality consumables, refilled toners, etc.

#### 16) Work calendar

Work schedules of the offices calendar in time bound manner to complete project work in time.

## 2. Application

- a) These General Conditions shall apply to the extent that they are not superseded by provisions in other parts of the Contract.

## 3. Use of Contract Documents and Information

- 1) The Service Provider shall not, without the Settlement Commissioner & Directorate of Land Records Office prior written consent, disclose the Contract, or any provision thereof, or any specification, plan, drawing, pattern, sample or information furnished by or on behalf of Settlement Commissioner & Directorate of Land Records Office in connection therewith, to any person other than a person employed by the Service Provider in performance of the Contract. Disclosure to any such employed person shall be made in confidence and shall extend only as far as may be necessary for purposes of such performance.

- 2) Any document, other than the Contract itself, shall remain the property of Settlement Commissioner & Directorate of Land Records Office and shall be returned (in all copies) to Settlement Commissioner & Directorate of Land Records Office on completion of the Service Provider's performance under the Contract if so required by Settlement Commissioner & Directorate of Land Records Office.

The Service Provider shall permit GIL/ Settlement Commissioner & Directorate of Land Records Office to inspect the Service Provider's accounts and records relating to the performance of the Service Provider and to have them audited.

#### **4. Patent Rights**

The Service Provider shall indemnify Settlement Commissioner & Directorate of Land Records Office against all third-party claims of infringement of patent, trademark or industrial design rights arising from use of the Goods or any part thereof in India.

#### **5. Inspections and Tests**

- 1) Authorized person in GIL/ Settlement Commissioner & Directorate of Land Records Office will verify scan softcopies on computer. There will be system generated counting and checking of the documents and based on that the certificate will be generated. the data on computer screen in a software entry online verification of scan softcopy of the documents. if data entry and scanned softcopies not found as per the original documents and norms prescribed by this office, they shall be generated again and again until they attain the prescribed norms and no extra payment will be made for the same. Verification of documents will be done simultaneously on the basis of completion scan softcopies document.
- 2) Bidders will have to maintain a register for handing over, and taking over of the hard copies of the documents, scanning and pagination purpose which will be verified and signed by the officers. Agency will hand over all the registers to respective offices after completion of work of the office.
- 3) No staff of Settlement Commissioner & Directorate of Land Records Office will be made available for the said work except for handing over and taking back the documents, receiving HDDs & indexed printouts. The entire verification of record will be done randomly and batch-wise by the Settlement Commissioner & Directorate of Land Records Staff of district, Taluka or City survey ward wise work or by GIL staff. It will be the onus of the bidder to ensure that the quality of the work is not compromised. If the quality is not satisfactory, it will amount to rejection of the entire batch. The bidder has to make a thorough verification of the quality at his own level before verification to be done by offices.
- 4) The documents shall be handed over to the bidder / or his authorized agent in the morning and shall be collected back by the staff of Settlement Commissioner & Directorate of Land Records Office at the end of the day.

- 5) The hard disk of the computers shall contain only the operating system, and the application software required for digital Scanning of the documents, and shall be formatted before leaving the premises for any reason.
- 6) The bidder has to submit the proposal for the work flow he intends to follow to ensure error free service. This will form a part of the technical bid.

#### **6. Delivery and Documents**

Delivery of the Goods shall be made by the Service Provider in accordance with the terms specified by Settlement Commissioner & Directorate of Land Records Office in the Notification of Award. The service provider will have to provide two sets of USB hard disk separately for color and black & white image to each office. Service provider will also make data entry and retrieval data entry in prescribed formats mentioned above in scope of work.

#### **7. Transportation**

Where the Service Provider is required under the Contract to transport the goods to a specified place of destination within Gujarat defined as Project site, transport to such place of destination in Gujarat including insurance, as shall be specified in the Contract, shall be arranged by the Service Provider, and the related cost shall be included in the Contract Price.

#### **8. Incidental Services**

The Service Provider is required to provide the following services, including additional services, if any.

- 1) Performance or supervision of the on-site assembly and/or start-up of the supplied Goods;
- 2) Furnishing of tools required for assembly and/or maintenance of the supplied Goods;
- 3) Furnishing of detailed operations and maintenance manual for each appropriate unit of supplied Goods;
- 4) Performance or supervision or maintenance and/or repair of the supplied Goods, for the period of time mentioned in the tender notification.

#### **9. Payment**

- 1) **All payments will be done to the agency after completion of the job.**
- 2) Payment will be worked out on the basis 50,000 documents pages scanned work done with data entry, upload & retrieval in the NIC software. Payment will be given on System generate certificate.
- 3) Any penalties imposed on the agency for non-performance will be deducted from the payments/ PBG.
- 4) All work contract tax, service tax and income tax will be deducted at source as per the prevalent rules & regulations at the time of making payments to the Bidder during the billing cycles.

- 5) Payment will be made within a month's time from the date of receipt of bill, provided there is no dispute.
- 6) It is binding on the agency to which the work will be allotted to complete the total job-work within the specified time-period as decided by Settlement Commissioner & Directorate of Land Records Office. In case of delay, the agency will be penalized proportionately. The amount of penalty will be adjusted against the amount payable to the agency for the job-work & the net payment will be made to the agency. For example, if the average delay is 10% then the agency will get 10% less amount per page quoted by him to the extent of the pages where the delay has occurred.

#### **10. Change Orders**

- 1) Settlement Commissioner & Directorate of Land Records Office may at any time, by written order given to the Service Provider, make changes within the general scope of the Contract in any one or more of the following:
  - a) Drawings, designs, or specifications, where Goods to be furnished under the Contract are to be specifically manufactured for Settlement Commissioner & Directorate of Land Records Office.
  - b) The place of delivery; and/or
  - c) The Services to be provided by the Service Provider.
  - d) The Quantity of goods to be supplied & or the locations of supply.
- 2) If any such change causes an increase or decrease in the cost of, or the time required for, the Service Provider's performance of any provisions under the Contract, an equitable adjustments shall be made in the Contract Price or delivery schedule, or both, and the Contract shall accordingly be amended. Any claims by the Service Provider for adjustment under this clause must be asserted within thirty (30) days from the date of the Service Provider's receipt of Settlement Commissioner & Directorate of Land Records change order.

#### **11. Delays in the Service Provider's Performance**

- 1) Delivery of the Goods and performance of the Services shall be made by the Service Provider in accordance with the time schedule specified by Settlement Commissioner & Directorate of Land Records Office.
- 2) If at any time during performance of the Contract, the Service Provider should encounter conditions impeding timely delivery of the Goods and performance of Services, the Service Provider shall promptly notify Settlement Commissioner & Directorate of Land Records Office in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the Service Provider's notice, Settlement Commissioner & Directorate of Land Records

Office shall evaluate the situation and may, at its discretion, extend the Service Provider's time for performance with or without a penalty, in which case the extension shall be ratified by the parties by amendment of the Contract.

- 3) The bidders shall read & understand the requirements thoroughly & shall adhere to the schedule strictly. The supply, installation & commissioning of Hardware & software at all locations shall be completed within 15 days from the date of signing the Contract Agreement.

**12. Penalty Clause**

a. If the Service Provider is not executing the contract to the satisfaction of Settlement Commissioner & Directorate of Land Records Office, then may invoke any or all of the following clauses.

- i. Forfeit the performance Guarantee Amount. Or
- ii. Impose a proportionate penalty of the delivered price of the Goods or unperformed services. Or
- iii. Terminate the contract without giving any notice.

**b. Quality:**

100% accuracy shall be maintained in scanning & data entry. For accuracy less than 100%, the penalty will be deducted as mentioned below.

c. Data Scanning and entry in software will be verified by department and if quality of work below mentioned standards then penalty will be done.

**d. Delays in deliverables:**

If the work is not completed within the stipulated time period, penalty@1% of the job cost per week's delay subject to a maximum of 20% will be deducted from the SP's Bill.

e. **Damage or Permanent loss of Documents:** The selected bidder shall be responsible to take care of documents during the process of scanning and data entry. If any documents are damaged during the process, the selected bidder shall be responsible to rectify it/ repair the same at its own cost. In case of any permanent loss or damage of documents, the penalty will be applicable as mentioned in SLA mentioned below.

**13. Termination for Default or Otherwise**

- 1) Settlement Commissioner & Directorate of Land Records Office may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Service Provider, terminate the Contract in whole or part:
  - a) If the Service Provider fails to deliver any or all of the Goods/Services within the Period/schedule specified in the Contract,
  - b) if the Service Provider fails to perform as per the performance standards.
  - c) If the Service Provider, in the judgment of Settlement Commissioner & Directorate of Land Records Office has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.
- 2) In Circumstances mentioned in a, b, c above Settlement Commissioner & Directorate of Land Records Office may exercise the following option: -
  - a) Direct the agency to leave the Hardware/Software in the offices of the SCNDLR or Dy. Dir Land Record of Division officer and terminate the Contract.
- 3) In case of premature termination of Contract for no fault of Service Provider Settlement Commissioner & Directorate of Land Records Office may exercise the following options:-
  - a) Direct the agency to take back the Hardware and without any additional compensation.
  - b) Direct the agency to leave behind the Hardware & pay him the cost of Hardware less the depreciation as per the Income Tax Act / Rules. The Settlement Commissioner & Directorate of Land Records may consult GIL as to the genuine cost of Hardware. Settlement Commissioner & Directorate of Land Records Office may also take suitable decision as to the system/platform software in consultation with GIL.

**14. Force Majeure**

- 1) For purposes of this clause, "Force Majeure" means an event beyond the control of the Service Provider and not involving the Service Provider's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the Purchase either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 2) If a force Majeure situation arises, the Service Provider shall promptly notify Settlement Commissioner & Directorate of Land Records Office in writing of such conditions and the cause thereof. Unless otherwise directed by Settlement Commissioner & Directorate of Land Records Office in writing, the Service Provider shall continue to perform its obligations under the Contract as far as it reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure.



**15. Termination for Insolvency**

Settlement Commissioner & Directorate of Land Records Office may at any time terminate the Contract by giving written notice to the Service Provider, if the Service Provider becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the Service Provider, provided that such termination will not prejudice or affect any right of action or remedy, which has accrued or will accrue thereafter to Settlement Commissioner & Directorate of Land Records Office.

**16. Resolution of Disputes**

The matter regarding any dispute shall first be sorted out at the level of Settlement Commissioner & Directorate of Land Records Office, Gandhinagar, Gujarat in consultation with GIL. If the dispute persists to remain unresolved then it will be entertained, heard & finalized as per the provisions of the Arbitration and Conciliation Act, 1996.

**17. Taxes and Duties**

The rates quoted shall be in Indian Rupees and shall be exclusive of all taxes.

**18. Binding Clause**

All decisions taken by Settlement Commissioner & Directorate of Land Records Office regarding the processing of this tender and award of contract shall be final and binding on all parties concerned.

**19 Manpower Support:**

- 1) The service provider will be bound to supply Support Manpower with good antecedents as specified in the Manpower deployment Plan.
- 2) All salaries and statutory benefits will have to be borne by the service provider & no payments will be made by Settlement Commissioner & Directorate of Land Records Office.
- 3) In case of absence of any of his employee, the service provider should provide alternative person the next day.
- 4) The service provider should ensure that the behavior of manpower is decent. The service provider will be held responsible for indecent behavior of manpower, & such employees should be immediately replaced when such matter is reported.
- 5) Agency will provide Identify cards at their own cost to responsible persons of the project so proper Co-ordination take place.
- 6) All statutory obligations of the service provider towards his employees shall be fulfilled by him and Settlement Commissioner & Directorate of Land Records Office shall not be responsible for any such obligations.

20. GIL/Settlement Commissioner & Directorate of Land Records Office, Gandhinagar, reserves the right:-  
  
To vary, modify, revise, amend or change any of the terms and conditions mentioned above; **or**

***II. Role of the Service Provider (SP)***
