### **Scope of Work and Additional Terms & Conditions**

#### 1. NVR installation Scope:

- a) Bidder has to supply, installation, testing, commissioning & 5 year warranty support of proposed NVR. Bidder is also responsible for necessary electrification of proposed devices including all accessories in the control center. The Control center will be located within the same campus of Raj Bhavan.
- b) The proposed solution shall be configured to view all the cameras in the site in a single screen.
- c) The images, video feeds displayed on the monitoring displays should display the camera ID for identification.
- d) The Control Room shall have, Monitoring device, networking devices as per the requirement and scope of work for monitoring the same.
- e) For local monitoring from other office of the same premised, bidder has to provide local monitoring software, which can be installed in desktop & works on window OS. So, that in same local network local monitoring will be done
- f) The successful bidder will be responsible for the integration of the existing Cameras (Vivotek Make) with the proposed solution (NVR) for recording & Monitoring of video feeds. The solution should be configured in such a way, so that the video feeds would be kept for 30 days. After 30 days, the video feeds would be overwritten unless it is flagged or marked by the office/appropriate authority of Raj Bhavan for investigation or any other purpose. Bidder have to quote 32 Ch NVR with 24 TB storage capacity.
- 2. **System Training:** This shall include providing hands on training related to system operation of the installed peripherals/equipment's to the designated/authorized representative of respective site after the successful commissioning of the system.
- 3. The bidder has to provide on-site 5 year warranty for all equipment's as mentioned in RFP.
- 4. Quoted NVR should have BIS Certification.
