## **(1) Introduction:**

*Gujarat Informatics Limited (GIL), on behalf of the General Administration Department, Gandhinagar (hereinafter referred to as the "Office") invites the Bid for fixing of rates of Postpaid Mobile Phone Services for Government Dignitaries and Officials on behalf of General Administration Department, Government of Gujarat.*

- Bidder shall submit their bids on <https://www.gil.nprocure.com>.

### **1. Part I: (EMD (Ernest Money Deposit) & Bid Processing Fees Section) :**

The Bidder will have to remit Non-Refundable Bid Processing Fees of **Rs. 2,950/-** & Earnest Money Deposit (E.M.D.) of **Rs. 50,000/-** (Rupees Fifty thousand) (Refundable) **on or before the date & hours of submission of bid (i.e. 23.08.2022 up to 1500 Hrs)** in a sealed cover at GIL office with the heading "Bid processing fees & EMD for Tender No. HWT130422631, Bid for fixing of rates of Postpaid Mobile Phone Services for Government Dignitaries and Officials on behalf of General Administration Department, Government of Gujarat.

- a. Bid processing fees must be in the form of Demand Draft in the name of "Gujarat Informatics Ltd." payable at Gandhinagar along with the covering letter.
- b. EMD as mentioned above, shall be submitted in the form of Demand Draft OR in the form of an unconditional Bank Guarantee (which should be valid up to validity of 6 months from the date of bid submission) of any Nationalized Bank (operating in India having a branch at Ahmedabad/ Gandhinagar) in the name of "Gujarat Informatics Ltd." payable at Gandhinagar (as per prescribed format given at Annexure A) and must be submitted along with the covering letter.
- c. Please affix the stamp of your company on the overleaf of the demand draft.
- d. **Note:** Failing to submit physical covers of EMD and bid processing fees at GIL on or before **23.08.2022 up to 1500 Hrs** may lead to the rejection of the bid
- e. Bid complete in all respects should be uploaded on or before the Bid due date.
- f. Interested and eligible Bidders are required to upload the technical criteria-related document in Technical Bid Section & commercial bid in Commercial Bid Section. The Bids should be accompanied by bid security & bid processing fees (non-refundable) as specified in this Bid Document. The Eligibility, Technical & Commercial Bid must be uploaded to <https://gil.nprocure.com> & the Bid Security and Bid Processing Fees must be delivered to the office of Gujarat Informatics Ltd.
- g. The Bid Processing Fees & Bid Security Section and Technical Section will be opened on the specified date & time in presence of the committee members and representatives of the bidders who choose to attend. The representative will be held responsible for all commitments made on behalf of the bidder and that will be considered valid for all further dealings related to this tender process.
- h. **Note:** Bidders who wish to participate in this bid will have to register on <https://gil.nprocure.com>. Further bidders who wish to participate in online bids will have to procure Digital Certificate as per Information Technology Act 2000 using which they can sign their electronic bids. Bidders can procure the same from (n) code solutions – a division of GNFC Ltd., or any other agency licensed by Controller of Certifying Authority, Govt. of India. Bidders who already have a valid Digital Certificate need not procure a new Digital Certificate.

2. ***Only Single Rate Quote, Which will apply uniformly against all services mentioned at I to III services against base rate schedule. More than one rate quote or differential quote for different services or conditional quotes will not be accepted and will lead to disqualification.***
3. ***From the above quote Fb will be decided with a base of 100. This would mean "0" quote would mean Fb=100; +10 % (premium or above base rate) will mean Fb=(1-10%)\*100=90; and -10% or discount of 10% against the base prices in the bid will mean Fb=(1+10%)\*100=110. The formula will be Fb = (1 - F)\*100. F will be a positive number when premium is quoted and will be a negative number when discount is quoted.***

- **Evaluation of the bid:**

***The bidding process will have two stages. In the first stage, Technical bids will be evaluated as per the qualifying criteria given with this document. Minimum score to qualify in the Technical Bid will be 60 marks. Financial Bids of only those who qualify in the technical bid stage will be opened. For the overall evaluation, weightage to the Technical and Financial Bid will be as follows:***

- I. 40% weightage is to be given to technical proposal submitted by bidder
- II. 60% weightage is to be given to financial offer schedule submitted by bidder.

**For Technical Score:**

$$T_n = T_b / T_{max} * 100$$

Where

T<sub>n</sub> = normalized technical score for the bidder under consideration

T<sub>b</sub> = absolute technical score for the bidder under consideration

T<sub>max</sub> = maximum absolute technical score obtained by any bidder

**For Financial Score:**

$$F_n = F_b / F_{max} * 100$$

Where

F<sub>n</sub> = Normalized financial score of the bidder under consideration

F<sub>b</sub> = Value arrived from the financial offer

F<sub>max</sub> = Maximum F<sub>b</sub> from amongst the bidder

**Overall Score:**

$$B_n = 0.4 * T_n + 0.6 * F_n$$

Where

B<sub>n</sub> = overall score of bidder under consideration

T<sub>n</sub> = Normalized Technical score for the bidder under consideration

F<sub>n</sub> = Normalized financial score of the bidder under consideration

**If tendering authority desires to negotiate then it will negotiate with only the bidder with the highest overall score (B<sub>n</sub>).**

## **(2) Terms and Conditions:**

---

1. The term of this Agreement will be initially for two years subject to the condition that GoG will review the quality of mobile phone service and tariff rates after six months and if service or the tariff rates, as the case may be, are not found satisfactory, agreement can be terminated by the GoG after giving one month's notice to Bidder.
2. The rates and agency will be finalized based on evaluation criteria defined in the bid. GAD will do the rate contract with a finalized agency with finalized rate
3. The Tariff plan can be changed & the rates can be revised with mutual consent.
4. In case of termination, the service provider shall continue to provide services till the alternate arrangements are made.
5. The period of rate contract with Government will be for a period of **two Years**. By mutual consent, the period of contract can be extended for further period of one year at a time
6. Airtime rates quoted by the service provider should be in accordance with the TRAI Regulations. It is expected that a favorable special package will be offered.
7. In case of downward revision of rates by the Company for the public at large, appropriate downward revision in the special package shall be made.
8. No upward revision in prices shall be allowed except Government taxes & levies as applied and circulated by TRAI during the course of validity of contract
9. Details of the Government Boards/Corporations, Organizations financed by Government with the number of users with the service provider should be provided.
10. If selected as service provider, the Bidder should extend the tariff plan as finalized to the organizations mentioned in above item no. 8 & to Govt. employees as well as retired Govt. officers on individual payment basis and include their mobile connecting the CUG without additional inclusion fees.
11. Bidder will have to provide new series in which first five digits will be unique and common for users of this tendered service. However at the option of the user, the service provider may provide for retaining the same number without charging any switchover fee. (Free Mobile Number Portability - MNP)
12. The priced bid should indicate the prices in the format/price schedule only.
13. Acceptance/alteration/rejection of any bid will be at the sole discretion of Government.
14. Dispute if any will be subject to Gandhinagar jurisdiction.
15. The selected bidder shall provide mobile number portability of all the numbers of Govt. of Gujarat including mobile numbers of Boards / Corporation, organizations financed by Government etc.

16. The EMD and Bid processing fees should reach in sealed cover on or before 23-08-2022 up to 15.00 hrs.
17. **Close User Group:** All the connections obtained through the Government of Gujarat will be in closed user group (C.U.G.).
18. **Customer Care and Helpline:** Bidder will nominate a Dedicated Service Manager for customer care and Helpline facilities, which would be available 24 hours during the entire agreement period.
19. **Quality of Coverage**
  1. Bidder will install additional Base Transceiver Station (BTS) wherever required for overall coverage improvement in the state.
  2. Bidder will daily monitor the congestion on each Base Transceiver Station (BTS). If any BTS is found overloaded, additional outdoor BTS will be installed with 15 days as per requirement.
20. Bidder will install at least two PRI line/ SIP trunk if required by Govt, with facility for minimum 30 simultaneous connections for Sachivalaya Integrated Communication Network (SICN) at his own cost, if he doesn't already have one. So that all outgoing traffic through SICN should not cause added cost burden in form of inter connecting or carrier charges.
21. In case of more than one equal bids i.e. total of qualification and price scoring, the bidders with equal bids shall be invited to submit their negotiated bids in closed envelope and the one with the minimum price shall be selected for the entrustment.
22. Bidders can seek written clarifications up to **2 days before pre bid meeting** to DGM(Tech.), Gujarat Informatics Ltd., Block No. 2, 2nd Floor, Karmayogi Bhavan, Sector 10A, Gandhinagar – 382 010 and the pre-bid meeting will be held as per the schedule. The office will try to clarify & issue amendments if any to all the bidders in the pre-bid meeting. No further clarification whatsoever will be entertained after the bid submission date.

  - c. In case of a successful Bidder, if the Bidder fails:
    - (i) To sign the Contract as mentioned above within the time limit stipulated by purchaser or
    - (ii) To furnish performance bank guarantee as mentioned above or
    - (iii) If the bidder is found to be involved in fraudulent practices.
    - (iv) If the bidder fails to submit the copy of purchase order & acceptance thereof.

We undertake to pay to the GIL/Purchaser up to the above amount upon receipt of its first written demand, without GIL/ Purchaser having to substantiate its demand, provided that in its demand GIL/ Purchaser will specify that the amount claimed by it is due to it owing to the occurrence of any of the abovementioned conditions, specifying the occurred condition or conditions.

This guarantee will remain valid up to **6 months** from the date of bid submission. The Bank undertakes not to revoke this guarantee during its currency without previous consent of the OWNER/PURCHASER and further agrees that if this guarantee is extended for a period as mutually agreed between bidder & owner/purchaser, the guarantee shall be valid for a period so extended provided that a written request for such extension is received before the expiry of validity of guarantee.

The Bank shall not be released of its obligations under these presents by any exercise by the OWNER/PURCHAER of its liability with reference to the matters aforesaid or any of them or by

reason or any other acts of omission or commission on the part of the OWNER/PURCHASER or any other indulgence shown by the OWNER/PURCHASER or by any other matter or things.

The Bank also agree that the OWNER/PUCHASER at its option shall be entitled to enforce this Guarantee against the Bank as a Principal Debtor, in the first instance without proceeding against the SELLER and not withstanding any security or other guarantee that the OWNER/PURCHASER may have in relation to the SELLER's liabilities.
