- 1. These links should be available in full duplex mode with sending and receiving available on the same circuit. For example, on a 10 Mbps circuit, 10Mbps sending and 10Mbps receiving should be possible simultaneously
- 2. Bidder needs to configure all router/network device/CPE/network accessories at all end-point offices/police station of Office of the ADGP (TS). Bidders is required to study all the requirement before participation in the bid. Any extra material/ quantity required for the project execution shall be supplied and deployed by the bidder at no extra cost to Office of the ADGP (TS). Rack space will be provided by Police station/The Office.
- 3. During the implementation, bidder have to ask rack space at nearest network switch of existing LAN.
- 4. UPS power will be provided by the Tenderer/Office of the ADGP (TS)
- 5. The bidders are expected to do a complete site survey for feasibility for providing required services and positioning of the terminating of new equipment as mentioned in this Bid. They should clearly state the equipment that will be deployed with its physical, electrical and any other related requirement. Any extra material/ quantity required for the project execution shall be supplied and deployed by the bidder at no extra cost to Office of the ADGP (TS).
- 6. The last mile connectivity i.e. police station Location should be connected through Fiber Cable only. In case Fiber connectivity is not possible then only RF connectivity shall be accepted but the bidder shall not connect through a wireless (RF) link more than 15% of the total last mile. (Type of Media fiber, 15% Radio (wireless))
- 7. In case of a last mile on wireless (RF) link, the bidder will ascertain that there is no interference in the channel provided to Tenderer by other Radio devices in the neighborhood. In case the channel provided has interference, then the bidder will apply and make available a licensed channel and compatible Radio Modems at its own cost. The

- Office/Tenderer, will not bear any extra cost towards the same. The Secured connectivity should be fully secured and should fulfill the security requirements as per the IT-Act applicable from time to time.
- 8. The last mile connectivity i.e. police station Location should be connected through Fiber Cable only. In case Fiber connectivity is not possible then only RF connectivity shall be accepted but the bidder shall not connect through a wireless (RF) link more than 15% of the total last mile. Type of Media fiber, 15% Radio (wireless)
- 9. The output at each location shall be Ethernet only.
- 10. The last mile connectivity at HO site Police Bhavan site shall be on Optical Fiber Only.
- 11. Bidder shall provide complete network diagram including detailed technical documentation and detailed Project Plan for all the locations mentioned.
- 12. Bidder has to supply, install, commissioning and provide CAMC support and configuration of Router/network device/CPE/network accessories. Bidder has also to supply necessary hardware like Rack, connector, etc at each locations.
- 13. All the locations listed have to be covered and no exclusion for any location shall be allowed. The successful bidder will have to ensure that all locations are connected within specified time frame and all locations should be technically and commercially feasible.
- 14. The bidder shall have proper upgradability availability for Secured connectivity and in case of requirement in future; the bidder shall do it within three week time.
- 15. The Bidder will be solely responsible for all liaison work, ROW permissions, statutory and regulatory approvals, project requirements/submission of payments, follow up etc. during project planning, execution, and tenure of contract.
- 16. The Bidder should be able to provide managed services to manage Secured connectivity end to end.
- 17. The configuration of IP plan and required routing protocols to run Secured connectivity will be responsibility of the bidder.
- 18. The Goods supplied & installed under this Contract (All the items covered under BoQ of the RFP) shall be fully insured by the selected bidder, against any loss or damage at the Tenderer's designated location for the entire contract period. The insurance taken should cover risks such as flood, theft, fire, earthquake, and cyclone.

3. **Network Monitoring**

- 1. The bidder should have state-of-art Network management center for troubleshooting round the clock to ensure uninterrupted services. This NOC should be manned by technical staff (24X7) and have call logging and escalation procedures. - 6. The Successful bidder will be responsible for discovery of the provided links and devices during the contract period through the TENDERER's NMS. However it shall be the bidder responsibility to monitor the system for the day to day operations and management through its own monitoring tool also."
- 7. The NMS access will be provided at central locations/any other locations as per requirement of Tenderer. The Office/nominated agency shall be able to generate reports as per the requirement from their assigned accesses.

4. Service Terms

- 1. It is mandatory for Bidder to deploy qualified professional to install, commission & maintain the network as defined under scope of work.
- 2. The Bidder will have to carry out reinstallation (within 100 meters) of the Local Lead Circuit and related equipment 'Free of Cost, if required. Beyond the 100 meters, it will be treated as a new location provided its outside the respective location/site boundary. The CAPEX cost will be given for all such links as per rate mentioned in the RFP & recurring charges will be considered as finalized in the RFP from the date of confirmation of the shifted link
- 3. If required, the Bidder may need to coordinate and approach various agencies working for

- this Project.
- 4. The Bidder needs to maintain the required security of the network as per the DIT/GoG Security guidelines.
- 5. The Bidder is responsible to maintain documentation on the progress of the work and will have to update the same on regular basis. Bidder will have to submit the progress reports regularly, as per the guide line issued by The Office.
- 6. In case of down, the Bidder needs to replace or repair the faulty part/component/device to restore the services at the earliest. The cost of the repairing or replacement of faulty Cable/component/device has to be entirely born by the Bidder.
- 7. All expenses related to cable/component/device, including hiring of specialized technical expertise, in case required, has to be borne by the Bidder as part of Contract Agreement.
- 8. The Bidder needs to make alternate arrangement in case of major failure happens in the network, due to which services may be effecting for longer period. (This refers major down time from Bidder's end. In such case, Bidder is required to make alternate arrangement to provide the connectivity at site location).
- 9. Bidder shall submit details of various reports generated by NMS like link availability, downtime, usage, fault & rectification etc. which are required for link(s) monitoring.
- 10. During Contract period, the bidder should provide all necessary support services as and when required by the office.
- 11. Bidder shall correct any faults and failures in the equipment and shall repair and replace worn or defective parts of the equipment during the office's normal working hours on all working days. In cases where unserviceable parts of the equipment need replacement. The Bidder shall replace such parts, at no extra cost to the office & replace with similar parts or those equivalent to similar parts in performance. The Bidder shall further ensure that the equipment is not down at any time.
- 12. All Router/network device/CPE/network accessories, and Rack shall be covered under comprehensive Maintenance Contract inclusive of all type of spares. No extra payment towards this additional spares will be given.
- 13. The Successful bidder will have to configure the all the equipment & terminate the link at the all said office locations. The successful bidder shall be responsible for implementation of the work as defined in the bid document.

- 16. The bidder has to terminate link in network switch available at various offices of Home Department. It will be bidder's responsibility that connectivity should be available at CCTV camera system and it is working.
- 17. <u>Bidder should have to follow the Government guideline/condition for "Call before U Dig" for the implementation</u>.
- 18. In case, the office will avail the facility from GFGNL/Bharat net for connectivity, then whenever the TENDERER/The Office wishes to withdraw/terminate a link, a written intimation will be placed with the selected bidder. Bidder is required to withdraw services at the location within 1 month, no charges shall be paid beyond the 1 month Duration.

5. Project Implementation:

- The Office, Government of Gujarat will be Engineer-In-Charge of the Project and all inspection, installation, commissioning and acceptance of work will be undertaken by them. All Invoices, Vouchers, Bills for supplied goods and services by the bidder under the scope of the work will be verified measured and accepted by the Engineer-In-Charge/ Agency appointed by GoG, for release of payment.
 - As part of implementation the bidder shall provide details of equipment that will be incorporated in the proposed system, material as required. The location for storing spare parts and quantity there on should also be clearly indicated.
- ... The bidder will have to complete provisional Acceptance Test of the equipment to the satisfaction of GoG. This period may be extended depending upon the fulfillment of Conditions Precedent.
- 3. Bidder shall provide the necessary technical support, Standard Operating Procedure (SOP) and other information to GoG and its user organizations in implementing the proposed system applications. GoG at any time during the currency of the Agreement should have access to the proposed sites.
- 4. Bidder shall arrange to obtain all statutory permission (If any) at no cost to the Government of Gujarat.
- 5. Bidder may have to work during Holidays and Sundays, according to the urgency of work. The Bidder will obtain such permission on his own in consultation with the Engineers-incharge. It will be the responsibility of the bidder to co-ordinate with all other agencies of Government of Gujarat in order to obtain NOC required to execute the job.
- 6. Bidder shall not disturb or damage the existing network of communication. If in case any damage to the network is done, the same shall be corrected with no extra cost. The agency shall also be responsible for paying penalty, as imposed by the service owner to which the damage is incurred.
- 7. Bidder shall treat all matters connected with the contract strictly confidential and shall undertake not to disclose, in any way, information, documents, technical data, experience and know how, without prior written permission from GoG.
- 8. Bidder shall have to furnish the documentation of the work undertaken in consultation with The Office
- 9. In the event of the delay in delivery of contracted services or services is not satisfactory the GoG may procure goods from else ware as prescribed in bid and Bidder shall be liable without limitations for the difference between the cost of such substitution and the price set forth in the contract for the goods involved i.e. at the risk and cost of the Bidder.
- 10. GoG reserves the right to visit any working site of the Bidder with prior intimation. The concern Bidder has to make necessary arrangement for the same.

The service provider has to maintain the quality levels on all the parameters mentioned above or as per the average guaranteed performance level mentioned against these parameters in the RFP.

If the quality levels of these parameters falls below the threshold levels on more than 50 occurrences during the quarter, then a penalty of 5% of billed value will be deducted from the quarterly payment.

8. Final Acceptance Test:

Acceptance Test will be conducted in as follows:

- 1. Bidder shall intimate GoG about provisioning of Secured connectivity bandwidth at the designated site(s) at least one week in advance so that necessary Inspection/testing required can be organized by GIL /GoG.
- 2. After successful configuration & termination of the required Link/bandwidth as per RFP in accordance with the requirements as mentioned in Price Bid, Final Acceptance Test will be conducted. After successful testing by the GIL/GoG (as per time line defined in this RFP), Acceptance Test Certificate will be issued by GIL/GoG to the bidder. Type of test for acceptance to be conducted on Secured connectivity and provision of testing equipment to conduct such test will provide by the bidder. The bidder will provide necessary support to staff who will be interested to carry out the test and also technical support.
- The date on which Acceptance certificate is issued shall be deemed to be the date of successful commissioning of the System. The 5 years support will start from the date of successful issuance of FAT certificate of the last link commissioned and tested from The Office.
- 4. Any delay by the bidder in the Acceptance Testing shall render the Bidder liable to the imposition of appropriate Penalties.
- 5. The first step will involve successful installation of sites phase wise within 120 Days of each cluster. The provisional acceptance of these sites will be defined as partial acceptance and O&M phase will be started for all the completed Locations accordingly (after completion of time line of 120 days of each cluster).
- 6. In case of partial commissioning of Links, as mentioned above O&M phase will start for links which are successfully commissioned as per Milestone defined in this RFP. The O&M

phase for the rest links will start only after the successful commission of the said links & issuance of FAT certificate by The Office/GIL/TPA

9. Penalty Clause

A. Penalties for Delay in Implementation

- 1. The successful bidder shall implement the Project from the date of PO/WO within specific time line defined in this RFP. In case of multiple locations, the date of successful commissioning for commencement of services for the locations of the client shall be as per the defined schedule in this RFP document. In case the services are not commissioned/implemented as per the agreed successful commissioning schedule (except such delay in commencement of services is not due to any act of omission or commission of the successful bidder), liquidated damages will be levied as under:
- 2. **For all locations:** The penalty @ 0.5% of the total Implementation cost of delayed locations as per price bid per location per week or part thereof, for the delayed site(s)/circuit(s) will be levied.
- 3. The maximum Liquidated damages would be limited to 10% of the total Implementation cost of PRICE BID as per above and also the Service Provider will be paid only from the date of actual commissioning of the link. The damages would be recovered from the dues payable to service provider. Delay in excess of 10 weeks after completion of actual delivery time, The Office/GIL reserves right to terminate the contract. In that case, the Performance Bank Guarantee of the bidder will be forfeited.

O Note:

- 1. During quarterly billing cycle, Link availability and SLA Penalty shall be calculated based on individual link
- 2. In case of link availability is less than 85% in any quarter than in that case the same shall be treated as non-availability of the link and payment for the said quarter for that link will not be considered while processing quarterly invoice.

B. Complaint resolution Penalty:

- SP/CP/Central offices -During the contract period, if the complaint/issue for the non-availability
 of Bandwidth due to any reason is not resolved within 4 hrs, the penalty of Rs. 1000 per hour
 will be levied in addition to Link downtime penalty defined in SLA.
- 2. Other Breach office (SOG, DCB, LCB, LIB, Cyber Police stations and Police Stations) *During* the contract period, if the complaint/issue for the non-availability of Bandwidth due to any reason is not resolved within 24 hrs, the penalty of Rs. 1000 per day will be levied in addition to Link downtime penalty defined in SLA.

- 3. Method for calculation of resolution time: Resolution time will start from the call logging by End-user through e-mail/telephone / Web interface etc. to the successful bidder till the issue is resolved.
 - 4. The overall penalty cap would be 10% of the Quarterly Invoiced amount

Note: Both the penalties are applicable. This penalties clause is applicable for user complaints w.r.t all the components/Bandwidth/software/hardware like router/network device/CPE/network accessories, etc. provided by bidder & Penalty would be calculated on the delay which are attributable by Bidder only.

10. Payment Terms:

Bidder may consider the one time CAPEX cost per link as per following:

- 1. One time CAPEX cost at each Police station will be Rs. 30,000/- (all inclusive with tax) (Per link per Police station)
- 2. One time CAPEX cost at each SP office will be Rs. 25,000/-(all inclusive with tax) (Per link per SP office level)
- 3. One time CAPEX cost at Central level/Police Bhavan will be Rs. 25,000/- (all inclusive with tax)

Payment: The Fixed one time CAPEX charge shall be paid as onetime payment on the successful FAT of the respective link as per the above one time CAPEX rate.

Quarterly Payment:

- Bandwidth recurring charges will be paid on quarterly basis upon completion of every quarter. Quarterly Bill process against the services provided by bidder for recurring bandwidth charges as per the Terms and Conditions of Service Level Agreement (SLA)
- 2. The Commissioning Date shall be the date of FAT certificate issued by GIL/The Office for commencement of the commercial billing cycle and payment of fees by The Office in terms of this agreement for a particular link.
- 3. 5 years of O&M period and regular Quarterly billing cycle will start after commissioning the last link i.e. Go-live of the Network. However, due to technical feasibility issues for connectivity at last mile Police station level office 90% completion of overall last mile locations can be sufficient for considering Go-live and start of O&M period.

- 4. In case of partial commissioning of Links, Payment of quarterly recurring charges will be paid on pro-rata basis for the said link for the duration till start of overall O&M period of the contract
- 5. The successful bidder shall submit reports for link availability, downtime, usage, fault & rectification (if any) etc. for each link separately, as generated by his monitoring system on monthly basis.
- 6. The successful bidder shall raise invoices on quarterly basis at the end of each quarter. Invoices issued shall be payable within 60 days of submission of the same.
- 7. In case of increase in bandwidth requirement with respect to the operational requirements, the prices will be revised accordingly, as per the agreement. In case of any reduction in tariff from time to time due to whatever reasons, the corresponding benefit would be passed on to GoG by the bidder.
- 8. Bidder's request for the payment shall be made at the end of each quarter by invoices along with following supporting documents:
 - I. Log of network parameters along with Service Down time calculation and uptime percentage.
 - II. Any other documents necessary in support of the services performances acceptable to the office.
- III. The Office shall verify all the supporting documents as prescribed and acceptable to The Office
- IV. On the receipt of such invoiced after verification by the office and after deducting Tax, other taxes and any penalties, The Office shall pay the amount. The service provider shall furnish all the tax payment receipts to The Office.

11. Over and above Bidder have to consider following points:

- Bidder have to co-ordinate with selected agency/implementing agency of CCTV camera and related accessories (in respective cluster) to be installed at various police station across the state.
- o The Office requires one (1) static IP at each location of Secured connectivity as per site requirement. Further, there may be approx. maximum 5% location (mostly district level office), where we may need 10 or 20 static IPs. The tenderer may ask for such provisioning as per actual site requirement at no additional cost.
