## **Notice Inviting Expression of Interest**

The Gujarat State Civil Supplies Corporation Ltd. (GSCSC) invites proposals from interested and eligible agencies for the demonstration and technical evaluation of Vehicle Tracking Devices (VTDs) in accordance with the technical requirements specified in this document.

### **1. About GSCSC**

GSCSC is a Government of Gujarat undertaking responsible for the procurement, storage, and distribution of essential commodities under the Public Distribution System (PDS) and other welfare schemes. GSCSC also manages logistics for various government initiatives and disaster relief operations.

### **2. Background**

GSCSC has implemented Vehicle Tracking and Management System (VTMS) integrated with the Integrated Lease Management System (ILMS) to monitor vehicle movement and ensure efficient, transparent logistics. To enhance these systems, GSCSC seeks to evaluate advanced, non-detachable GPS-based or any other technology based Vehicle Tracking Devices for its fleet of 2000 nos. vehicles for food distribution system in the entire state including no coverage zones.

### **3. Terms of Reference:**

#### **Submission of Application**

- Agencies are invited to submit a proposal on (n) procure platform and arrange for a demonstration of their VTD(s) solution in accordance with the technical requirements specified.
- The proposed solution must support vehicle location tracking, ignition status, speed monitoring, geo-fencing, low battery and tempering alert.
- Each agency must submit a statement of compliance with the minimum technical specifications and provide prescribed test certifications.
- The price estimation for unit solution per vehicle to be submitted along with proposal.

#### **Required Submission Documents:**

- Cover letter expressing interest to participate
- Company profile and relevant credentials
- Details of products/solutions offered
- Case studies/past deployments
- Technical brochures/specifications
- Declaration of non-blacklisting
- Land Border undertaking for product and organization

### **4. Scope of Work**

The EoI is for the demonstration of non- detachable GPS-based or any other technology-based vehicle tracking solution capable of:

- Real-time location tracking
- Route deviation
- Geo-fencing capability
- Alert for unauthorized halt on route

- Alert for device tempering
- Monitoring of weight variation during transit or at halt before delivering at destination

**Key Features Required:**

- Supply and delivery of non-detachable GPS/GPRS or sim based devices conforming to applicable standards
- Installation and commissioning in designated vehicles/assets
- Integration with existing tracking/monitoring platforms
- Tampering, battery low, or device deactivation alerts must be triggered to VTMS

**Technical Specifications:**

- GPS tracking devices with GSM/4G capability
- Web-based and mobile-accessible tracking platform
- Real-time location with geofencing
- Trip history and reporting (speed, routes, idling, etc.)
- Dashboard with real-time monitoring, analytics, and reporting
- Capability for integration with existing fleet management tools

**5. Role of the Service Provider**

- Provide technical support for integration and maintenance of VTDs with the VTMS portal
- Test device performance as per GSCSC requirements
- Submit reports at defined intervals as per GSCSC requirements

**6. Application Preparation and Submission**

- All costs related to proposal preparation and participation in demonstration/testing are to be borne by the agency.
- The demonstration should be provided till successful completion of the POC at GSCSC premises/vehicles.
- Proposals must be complete and to be submitted in English, in a sealed envelope (The technical proposal and the financial proposal must be submitted separately in sealed envelopes.) clearly marked as follows:
