Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imburse the cost of such service / rectification to the Buyer.

17. **Generic**

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

18. **Buyer Added Bid Specific ATC**

Bidder Past Experience: The bidder must have successfully executed/completed at least one single order of Rs. 24 Lacs of estimated bid value or 2 Orders each of Rs. 15 Lacs of estimated bid value or 3 Orders each of Rs.12 Lacs of estimated bid value for similar product / services in last 3 years to any central/ state Government / PSU/ Listed Company.

Note: Bidder's experience, bidder's turn over criteria will not be considered of GeM bid. However, bidder must match eligibility criteria, experience, bidder's turn over criteria, etc.as per Buyer Added text based ATC and will be considered for evaluation. EMD should submitted by bidder as per GEM.
