Eligibility Criteria for the bidder

- **Bidder Turn over:** The Bidder must have average annual turnover of Rs. 1.60 Cr in last three financial Years (2022-23, 2023-24, 2024-25). The copies of Audited Annual Accounts/Statutory CA Certificate for last three years shall be uploaded along with the bid
- The bidder must have one office in Gujarat. Please upload the copy of any one of the following: Property tax bill/Electricity Bill/Telephone Bill/GST Registration/Lease agreement etc. OR if bidder do not have office in Gujarat then at the time of bid submission, they will have to submit undertaking letter to open office in Gujarat within 15 days after award of the contract.
- The bidder should be authorized by its OEM (Apple) for Tablet to quote the bid. (Document is required with bid no. must be mentioned).
- **Past Performance Criteria (Bidder):**
 - The bidder must have successfully executed/completed at least
 - one single order of 88 Qty or

for tablet/I-Pad in last 3 years before the bid opening date to any central / state Government / PSU/ Listed Company. Copies of relevant contracts to be submitted along with bid.

- Bidder & OEM of quoted item should not be blacklisted/debarred by any state government / central government / PSU in last three years as on last date of bid submission. Bidder & OEM will have to submit undertaking letter at the time of bidding.
- Technical compliance shall be submitted on the OEM's letterhead.
- No bidders will be exempted from Past Performance criteria.

Note:

- Bidder & OEM of the quoted product must meet eligibility criteria as mentioned above only & Eligibility Criteria as mentioned above will be considered for evaluation.
- Consortium is not allowed.
- If OEM would like to participate through their authorized partner, then the partner must be Authorized by OEM. OEM & their authorized Partner should not participate simultaneously & only one of them should participate.

Terms & Conditions:

- The last date of submission of bid on the website <https://tender.nprocure.com> is as mentioned above only. **No physical bids will be accepted.** However, if required, GIL reserves the right to ask the bidders to submit documents, required during evaluation process in physical form also.
- Amendment of Bidding Documents (Corrigendum)
 - At any time prior to the deadline for submission of bids, GIL for any reason, whether its own initiative or in response to the clarification request by a prospective bidder, may modify the bid by way of amendment and publishing it on website.
 - The corrigendum will be published on website <https://tender.nprocure.com> & www.gil.gujarat.gov.in.
 - GIL, at its discretion, may extend the deadline for the submission of bids.
- Only one make & model should be quoted by bidder in the bid.
- Bidder will have to supply all the necessary required accessories/cables with quoted item for make the supplied items functional/operational.
- Bidder will have to submit Brochure & Technical specification compliance on OEM letter head with duly signed & stamped along with bid
- No “End of Life” product should be quoted in the bid. Make & Model quoted by the bidder should be available till the contract period (duly supported for spares/OEM support for contract period). However, during the contract period, if the OEM stops manufacturing the quoted model and the bidder will offer to supply new model (equivalent or higher) instead of quoted model, the bidder is liable for the delay late delivery and applicable penalty will be levied for the delay including time lase in approval of change model request. Hence, the bidder/OEM is expected to offer/quote a make & model, which will be available for at least contract period.
- Bid Currency – Prices shall be quoted in Indian Rupees only.

- In exceptional circumstances, GIL may solicit the Bidder's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing. A Bidder may refuse the request without forfeiting its E.M.D. A Bidder granting the request will not be permitted to modify its bid.
- The Successful bidder has to submit copy of acceptance of purchase order & copy of PBG, offer of the material for inspection at GIL office.
- Only manufacturers of quoted goods are eligible for EMD exemption, Traders are excluded & bidder is a trader, not a manufacturer of quoted items. Hence, Bidder is not eligible for the EMD exemption as a trader.
- The E.M.D. may be forfeited:
 - (a) if a Bidder withdraws its bid during the period of bid validity
 - (b) In case of a successful Bidder, if the Bidder fails:
 - (i) If the bidder is found to be involved in fraudulent practices.
 - (ii) If the successful bidder fails to submit the Performance Bank Guarantee. GIL also Reserve the right to blacklist such bidder from participating in future tenders if sufficient cause exists
- Price shall be inclusive of all freight, forwarding, transit insurance and installation charges.
- Before delivery at respective site, bidder will have to offer inspection in the manner as decided by GIL before delivering to the respective sites or at customer sites. The arrangement of inspection of goods has to be done by supplier. Any deviation found in the specification of the produced goods or delivered goods after inspection from the tender specifications will lead to the cancellation of the order, forfeiture of EMD/PBG and prohibition in the participation in the future purchase of Government of Gujarat. GIL/GoG will not be responsible for any time delay which may arise due to any deviation from the bid technical specification found at the time of inspection and the bidder has to deliver and install the ordered goods within prescribed time limit.
- In case of successful bidder is found in breach of any condition(s) of bid or supply order/work order, at any stage during the course of supply / installation or warranty period, the legal action as per rules/laws, shall be initiated against the successful bidder and EMD/PBG shall be forfeited, besides debarring and blacklisting the bidder concerned for the time period as decided by Govt., for further dealings with GoG.
- The Successful bidder has to submit Performance Bank Guarantee @ 5% of total order value within 07 days from the date of issue of order by GIL (for warranty period + extra 2 months) (from banks operating in India having branch at Ahmedabad/ Gandhinagar) as per the G.R. issued by Finance Department or further instruction issued by Finance department time to time in the name of Purchasing Department & submit copy of the same at GIL.
- Successful bidders will have to sign the contract upon receiving the Purchase order with the purchaser(s) within 10 working days from the date of Purchase order. (The draft of the Contract form is attached herewith)
- The successful Bidder's E.M.D. will be returned upon the Bidder signing the Contract and furnishing the Performance Bank Guarantee @ 5% of the total order value, offer of inspection of the ordered

material, submission of warranty certificates as asked in the bid and after completion of bid validity whichever is later.

- The bidder will have to supply, install, maintain and provide operational training of supplied hardware, Operating Software and carry out necessary integration at office.
- Price shall be inclusive of all freight, forwarding, transit insurance and installation charges.
- Prices shall be in Indian Rupees. The prices shall strictly be submitted in the given format. The tax (GST) components as applicable shall be mentioned separately in the respective columns.
- Late Bids – The bidder will not be able to submit the bid after final submission date and time.
- Modification and Withdrawal of Bids
 - No bids will be allowed to be modified subsequent to the final submission of bids.
 - No bid will allowed to be withdrawn in the interval between the deadline for submission of bids and the expiry of the bid validity. Withdrawal of a bid during this interval will result in the forfeiture of bidder's E.M.D.
- Bids will be opened with the buyer's private digital key at bid opening time.
- **Evaluation of the bids:** After the closing time of submission, GIL/GOG committee will verify the submission of Bid Processing Fees & EMD as per bid terms and conditions. The eligibility criteria evaluation will be carried out of the responsive bids. The technical bids of the bidders who are complying with all the eligibility criteria will be opened and evaluated next of technical evaluation. The financial bid of the technically qualified bidders will be opened. Successful bidder (i.e. L1) will be decided based on the lowest sum total of rates of all line items without tax as mentioned in the financial bid section.

Delivery timeline: within 15 days from the date of contract order.

Delivery location: As confirmed by the Legal Department, Gandhinagar.

Warranty:

- **Warranty:** Carry-in warranty for 1 years from OEM from the date of supply.
- If any equipment gives continuous trouble, say more than 3 times in one month during the warranty period, the bidder shall replace the same with new equipment without any additional cost to the purchaser.
- Maintenance service: Free maintenance services shall be provided by the Bidder during the period of warranty.
- In case, bidder is not providing satisfactory support & doing unwarranted delay in providing warranty support, Government offices reserves right to repair the equipment at risk & cost of the bidder (after providing notice/cure period of 10 days to bidder)

Penalty Clause for delay in delivery & installation

- If the bidder fails to deliver and install the requisite hardware and operating software within the time limit as mentioned in the bid, then 0.5% of the contract value of delayed qty. per week or part of the week of delayed period shall be deducted proportionately.
- The amount of penalty for delay in delivery & installation shall be subject to a maximum limit of 10% of the total contract value.
- In case, the selected bidder does not supply the ordered items for any reason, (after providing notice/cure period of 10 days to bidder) the bidder will be liable to pay the difference amount to the purchaser, over and above the performance guarantee, which indenter department must pay to the next or other selected bidder for purpose of the said items.
- In case, delay for delivery and installation of the requisite hardware and operating software will be due to purchasing Department OR its field offices, then penalty will not be imposed.

Operational/Warranty period Penalty:

- During warranty period, if the complaint is not resolved within 48 hrs the penalty of Rs. 300 per day for Tablet will be levied. However, if the complaints not resolved within 7 days then from 8th day to 14th day, penalty would be levied @ 150% and from 15th day onwards penalty @ 200% of the above rates would be levied. The amount of penalty will be recovered from the Performance bank guarantee during warranty period.
- The amount of Operational/Warranty period Penalty shall be subject to a maximum limit of 5% of the total contract value.

Payment Structure:

- No advance payment will be made.
- 100% payment after successful inspection and delivery of the ordered goods. The inspection will be done as decided by GIL.

The pre-queries / clarifications if any should be submitted in writing to Gujarat Informatics Limited at least on or before 2 days of pre-bid meeting date. Thereafter the queries / clarifications received from the bidders will not be entertained.

- 3 In consideration of the payments to be made by the Purchaser to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Purchaser to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4 The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
